CONCURRENT RESOLUTION

Directing the Clerk of the House of Representatives to make
corrections in the enrollment of H.R. 3672.

1 *Resolved by the House of Representatives (the Senate*
2 *concurring)*, That, in the enrollment of the bill (H.R.
3 3672) making appropriations for disaster relief require-
4 ments for the fiscal year ending September 30, 2012, and
5 for other purposes, the Clerk of the House of Representa-
6 tives shall make the following corrections:

1 (1) In the heading for title III, strike “PROVI-
2 SION” and insert “PROVISIONS”.

3 (2) After section 301, insert the following new
4 section:

5 “SEC. 302. (a) ACROSS-THE-BOARD RESCISSION.—
6 There is hereby rescinded an amount equal to 1.83 percent
7 of—

8 “(1) the budget authority provided for fiscal
9 year 2012 for any discretionary account in any fiscal
10 year 2012 appropriation Act (except the Department
11 of Defense Appropriations Act, 2012 and the Mili-
12 tary Construction and Veterans Affairs and Related
13 Agencies Appropriations Act, 2012); and

14 “(2) the budget authority provided in any ad-
15 vance appropriation for fiscal year 2012 for any dis-
16 cretionary account (other than for the Department
17 of Veterans Affairs) in any prior fiscal year appro-
18 priation Act.

19 “(b) PROPORTIONATE APPLICATION.—Any rescission
20 made by subsection (a) shall be applied proportionately—

21 “(1) to each discretionary account and each
22 item of budget authority described in such sub-
23 section; and

24 “(2) within each such account and item, to each
25 program, project, and activity (with programs,

1 projects, and activities as delineated in the appro-
2 priation Act or accompanying reports for the rel-
3 evant fiscal year covering such account or item, or
4 for accounts and items not included in appropriation
5 Acts, as delineated in the most recently submitted
6 President’s budget).

7 “(c) EXCEPTIONS.—The rescission in subsection (a)
8 shall not apply to budget authority provided for fiscal year
9 2012 that is designated by the Congress as being for—

10 “(1) disaster relief pursuant to section
11 251(b)(2)(D) of the Balanced Budget and Emer-
12 gency Deficit Control Act of 1985; or

13 “(2) Overseas Contingency Operations/Global
14 War on Terrorism pursuant to section 251(b)(2)(A)
15 of the Balanced Budget and Emergency Deficit Con-
16 trol Act of 1985.

17 “(d) SUBSEQUENT APPROPRIATIONS LAWS.—In the
18 case of any fiscal year 2012 appropriation law enacted
19 after the enactment of this section, any rescission required
20 by subsection (a) shall take effect immediately after the
21 enactment of such law.

22 “(e) OMB REPORT.—Not later than 30 days after
23 the date of the enactment of this Act, the Director of the
24 Office of Management and Budget shall submit to the
25 Committees on Appropriations of the House of Represent-

1 atives and the Senate a report specifying the account and
2 amount of each rescission made pursuant to subsection
3 (a).”.
