# A BILL

To modify the boundary of the Oregon Caves National Monument, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

#### **3** SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Oregon Caves Revital-

5 ization Act of 2011".

#### 6 SEC. 2. PURPOSE.

7 The purpose of this Act is to add surrounding land8 to the Monument—

9 (1) to enhance the protection of the resources10 associated with the Monument; and

| 4  | (1) MAP.—The term "map" means the map ti-          |
| 5  | tled "Oregon Caves National Monument and Pre-      |
| 6  | serve" numbered 150/80,023, and dated May 2010.    |
| 7  | (2) MONUMENT.—The term "Monument"                  |
| 8  | means the Oregon Caves National Monument estab-    |
| 9  | lished by Presidential Proclamation Number 876 (36 |
| 10 | Stat. 2497), dated July 12, 1909.                  |
| 11 | (3) NATIONAL PRESERVE.—The term "National          |
| 12 | Preserve" means the National Preserve designated   |
| 13 | by section $4(a)$ .                                |
| 14 | (4) Secretary.—The term "Secretary" means          |
| 15 | the Secretary of the Interior.                     |
| 16 | (5) Secretary concerned.—The term "Sec-            |
| 17 | retary concerned" means—                           |
| 18 | (A) the Secretary of Agriculture (acting           |
| 19 | through the Chief of the Forest Service), with     |
| 20 | respect to National Forest System land; and        |
| 21 | (B) the Secretary of the Interior, with re-        |
| 22 | spect to land managed by the Bureau of Land        |
| 23 | Management.  |
| 24 | (6) STATE.—The term "State" means the State        |
| 25 | of Oregon.   |

3 (a) IN GENERAL.—The Monument shall be known
4 and designated as the "Oregon Caves National Monument
5 and Preserve". The land identified on the map as "Pro6 posed Addition Lands" shall be designated as a National
7 Preserve.

8 (b) LAND TRANSFER.—The Secretary of Agriculture9 shall—

10 (1) transfer approximately 4,070 acres of land
11 identified on the map as the "Proposed Addition
12 Lands" to the Secretary to be administered as part
13 of the Oregon Caves National Monument and Pre14 serve; and

(2) adjust the boundary of the Rogue RiverSiskiyou National Forest to exclude the land transferred under paragraph (1).

18 (c) BOUNDARY ADJUSTMENT.—The boundary of the
19 National Monument is modified to exclude approximately
20 4 acres of land—

- 21 (1) located in the City of Cave Junction; and
- (2) identified on the map as the "Cave JunctionUnit", as depicted on the map.

24 (d) AVAILABILITY OF MAP.—The map shall be on file
25 and available for public inspection in the appropriate of26 fices of the National Park Service.

(e) REFERENCES.—Any reference in a law, map, reg ulation, document, paper, or other record of the United
 States to the Monument shall be considered to be a ref erence to the "Oregon Caves National Monument and Pre serve".

#### 6 SEC. 5. ADMINISTRATION.

7 (a) IN GENERAL.—The Secretary, acting through the
8 Director of the National Park Service, shall administer the
9 National Monument and Preserve in accordance with—

10 (1) this Act;

(2) Presidential Proclamation Number 876 (36
 Stat. 2497), dated July 12, 1909; and

(3) any law (including regulations) generally
applicable to units of the National Park System, including the National Park Service Organic Act (16
U.S.C. 1 et seq.).

17 (b) FIRE MANAGEMENT.—As soon as practicable 18 after the date of enactment of this Act, in accordance with 19 subsection (a), the Secretary shall revise the fire manage-20 ment plan for the Monument to include the National Pre-21 serve and, in accordance with the revised plan, carry out 22 hazardous fuel management activities within the bound-23 aries of the National Monument and Preserve.

24 (c) EXISTING FOREST SERVICE CONTRACTS.—The25 Secretary shall allow for the completion of existing Forest

Service stewardship and service contracts executed as of 1 2 the date of enactment of this Act and shall recognize the 3 authority of the Secretary of Agriculture for the purpose 4 of administering the existing Forest Service contracts through their completion. All terms and conditions of ex-5 isting Forest Service contracts shall remain in place for 6 7 the duration of those contracts. Any such liability existing 8 at the time of enactment of this Act shall be that of the Forest Service. 9

10 (d) GRAZING.—The Secretary may allow the grazing 11 of livestock within the preserve to continue where author-12 ized under permits or leases in existence as of the date 13 of enactment of this Act. Grazing shall be at no more than 14 the current level, as measured in Animal Unit Months, 15 and subject to applicable laws and National Park Service 16 regulations.

## 17 SEC. 6. VOLUNTARY GRAZING LEASE OR PERMIT DONA-18 TION PROGRAM.

19 (a) DONATION OF LEASE OR PERMIT.—

20 (1) ACCEPTANCE BY SECRETARY CON21 CERNED.—The Secretary concerned shall accept the
22 donation of a grazing lease or permit from a leasee
23 or permittee for—

| 1  | (A) the Big Grayback Grazing Allotment                      |

| 8  | (2) TERMINATION.—With respect to each per-                  |
| 9  | mit or lease donated under subparagraph (a), the            |

| 11 | (A) terminate the grazing permit or lease;                  |

| 13 | (B) ensure a permanent end to grazing on                    |
| 14 | the land covered by the permit or lease.                    |
| 15 | (b) Effect of Donation.—A lessee or permittee               |
| 16 | that donates a grazing lease or grazing permit (or a por-   |
| 17 | tion of a grazing lease or grazing permit) under this sec-  |
| 18 | tion shall be considered to have waived any claim to any    |
| 19 | range improvement on the associated grazing allotment or    |
| 20 | portion of the associated grazing allotment, as applicable. |
| 21 | SEC. 7. HUNTING, FISHING, AND TRAPPING.                     |
| 22 | (a) IN GENERAL.—Except as provided in subsection            |
| 23 | (b), the Secretary shall permit hunting, fishing, and trap- |

ping on land and water within the National Preserve in

accordance with each applicable law (including regula tions) of the Federal Government and the State.

3 (b) ADMINISTRATIVE EXCEPTIONS.—In accordance 4 with subsection (c), the Secretary may designate areas in 5 which, and establish limited periods during which, no 6 hunting, fishing, or trapping may be permitted within the 7 National Preserve due to concerns relating to—

8 (1) public safety;

9 (2) the administration of the National Preserve;10 or

(3) the compliance by the Secretary with anyapplicable law (including regulations).

(c) CONSULTATION WITH APPROPRIATE STATE
AGENCY.—Except to respond to a situation that the Secretary determines to be an emergency, the Secretary shall
consult with the appropriate agency of the State before
taking any act to close any area within the National Preserve to hunting, fishing, or trapping.

#### 19 SEC. 8. EFFECT.

Nothing in this Act affects the authority or responsibility of the State to carry out any law or duty of the
State relating to fish and wildlife on areas located within
the National Preserve.

# 1SEC. 9. WILD AND SCENIC RIVER DESIGNATION, RIVER2STYX, OREGON.

3 Section 3(a) of the Wild and Scenic Rivers Act (16
4 U.S.C. 1274(a)) is amended by inserting the following
5 paragraph:

6 "(\_\_\_) RIVER STYX, OREGON.—The subterra7 nean segment of Cave Creek, known as the River
8 Styx, to be administered by the Secretary of the In9 terior as a scenic river.".

10sec. 10. WILD AND SCENIC RIVER DESIGNATION FOR11study.

Section 5(a) of the Wild and Scenic Rivers Act (16
U.S.C. 1276(a)) is amended by adding at the end the following:

15 "(\_\_\_) OREGON CAVES NATIONAL MONUMENT
16 AND PRESERVE, OREGON.—

17 "(A) CAVE CREEK, OREGON.—The 2.618 mile segment of Cave Creek from the head19 waters at the River Styx to the boundary of the
20 Rogue River Siskiyou National Forest.

21 "(B) LAKE CREEK, OREGON.—The 3.622 mile segment of Lake Creek from the head23 waters at Bigelow Lakes to the confluence with
24 Cave Creek.

| 15 | AND PRESERVE, OREGON.—Not later than 3 years             |
| 16 | after funds are made available to carry out this         |
| 17 | paragraph, the Secretary shall complete the study of     |
| 18 | the Oregon Caves National Monument and Preserve          |
| 19 | segments designated for study in subsection (a), and     |
| 20 | shall submit to Congress a report containing the re-     |
| 21 | sults of the study.".                                    |
