Ms. FOXX, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 1911) to amend the Higher Education Act of 1965 to establish interest rates for new loans made on or after July 1, 2013, and for other purposes.

- 1 *Resolved*, That upon the adoption of this resolution
- 2 it shall be in order to consider in the House the bill (H.R.
- 3 1911) to amend the Higher Education Act of 1965 to es-
- 4 tablish interest rates for new loans made on or after July
- 5 1, 2013. All points of order against consideration of the
- 6 bill are waived. In lieu of the amendment in the nature

1 of a substitute recommended by the Committee on Edu-
2 cation and the Workforce now printed in the bill, an
3 amendment in the nature of a substitute consisting of the
4 text of Rules Committee Print 113-12 shall be considered
5 as adopted. The bill, as amended, shall be considered as
6 read. All points of order against provisions in the bill, as
7 amended, are waived. The previous question shall be con-
8 sidered as ordered on the bill, as amended, and on any
9 further amendment thereto, to final passage without inter-
10 vening motion except: (1) one hour of debate equally di-
11 vided and controlled by the chair and ranking minority
12 member of the Committee on Education and the Work-
13 force; and (2) one motion to recommit with or without in-
14 structions.

15 SEC. 2. In the engrossment of H.R. 1911, the Clerk
16 shall—

- 17 (a) await the disposition of H.R. 1949;
- 18 (b) add the text of H.R. 1949, as passed by the
19 House, as new matter at the end of H.R. 1911;
- 20 (c) conform the title of H.R. 1911 to reflect the addi-
21 tion of the text of H.R. 1949, as passed by the House,
22 to the engrossment;
- 23 (d) assign appropriate designations to provisions
24 within the engrossment; and (e) conform cross-references
25 and provisions for short titles within the engrossment.

1 SEC. 3. On any legislative day during the period from
2 May 24, 2013, through May 31, 2013—

3 (a) the Journal of the proceedings of the previous day

4 shall be considered as approved; and

5 (b) the Chair may at any time declare the House ad-
6 journed to meet at a date and time, within the limits of
7 clause 4, section 5, article I of the Constitution, to be an-
8 nounced by the Chair in declaring the adjournment.

9 SEC. 4. The Speaker may appoint Members to per-
10 form the duties of the Chair for the duration of the period
11 addressed by section 3 of this resolution as though under
12 clause 8(a) of rule I.

13 SEC. 5. The Committee on Appropriations may, at
14 any time before 6 p.m. on Wednesday, May 29, 2013, file
15 privileged reports to accompany measures making appro-
16 priations for the fiscal year ending September 30, 2014.

17 SEC. 6. The Committee on Agriculture may, at any
18 time before 6 p.m. on Wednesday, May 29, 2013, file a
19 report to accompany H.R. 1947.
