Coburn Amendment No. 1369 (to Amendment No. 1365), to require expenditures by every Senate office be posted online for the public to review. **Pages S7121–22**

DeMint Amendment No. 1370 (to Amendment No. 1365), to direct the Architect of the Capitol to engrave the Pledge of Allegiance to the Flag and the National Motto of “In God We Trust” in the Capitol Visitor Center. **Pages S7123–24**

Nelson (NE) Amendment No. 1365, in the nature of a substitute. **Pages S7121–26**

#### Rejected:

By 31 yeas to 61 nays (Vote No. 215), McCain Amendment No. 1366 (to Amendment No. 1365), to strike the earmark for the Durham Museum in Omaha, Nebraska. **Pages S7121, S7125–26**

During consideration of this measure today, Senate took the following action:

Chair sustained a point of order against DeMint Amendment No. 1367 (to Amendment No. 1365), to amend title 31, United States Code, to reform the manner in which the Board of Governors of the Federal Reserve System is audited by the Comptroller General of the United States and the manner in which such audits are reported, as being in violation of Rule XVI of the Standing Rules of the Senate, which prohibits legislation on an appropriation bill, and the amendment thus fell. **Pages S7124**

By 70 yeas to 23 nays (Vote No. 216), Senate determined that the point of order against Nelson (NE) Amendment No. 1365 (listed above), as being in violation of article 1, section 8 and the 10th Amendment of the United States Constitution, was not well-taken. **Page S7126**
