#### **INTRODUCTION BY SENATOR RICHARD LUGAR, CHAIRMAN, SENATE COMMITTEE ON FOREIGN RELATIONS**

This review and report of activities of the Committee on Foreign Relations during the 107th Congress is submitted in response to the requirements of Rule XXVI 8(b) of the Standing Rules of the Senate, which stipulate that all standing committees report to the Senate, not later than March 31 of each odd-numbered year, on its legislative activities during the preceding Congress.

During the 107th Congress, the Committee had two Chairmen, the result of the extraordinary switch in control of the Senate which occurred in June 2001. Thus, Senator Helms presided over the Committee from January to early June 2001; Senator Biden chaired the Committee from early June 2001 to the end of 2002.

The Committee was affected, as were all others in Congress, by the tragic attacks of September 11, 2001, and the anthrax attack on the United States Senate in the autumn of 2001. The former resulted in increased focus by most Senate committees, including this one, on the threat of terrorism; the latter event had a practical effect of displacing the Committee from its main hearing room and the Committee staff from its offices for a period of time. Despite the change in control and the anthrax attacks, however, the work of the Committee was not materially disrupted, and it was a productive Congress.

The major legislative project of the Committee was the Foreign Relations Authorization Act, Fiscal Year 2003 (P.L. 107-228), which included the State Department Authorization Act and the Security Assistance Act. This law included major provisions such as an authorization of debt relief for Russia in exchange for investment in non-proliferation activities, a revision of the “drug certification” law, and important framework legislation to guide U.S. pol-

icy in Tibet and East Timor. The law also finished a six-year long project, begun by Senators Helms and Biden in 1997, to pay back U.S. arrears to the United Nations (under the United Nations Reform Act of 1999, also known as the “Helms-Biden” law). The Committee also produced major legislation guiding U.S. policy on the reconstruction of Afghanistan. Other significant bills were initiated by Committee members and approved by the Senate, but were not acted on by the House of Representatives. These bills addressed issues such as bioterrorism, HIV/AIDS, and the Peace Corps.

The Committee reported 20 treaties, 19 of which were approved by the Senate. These included two major UN treaties on terrorism, two treaties to advance protection around the world of children, several bilateral law enforcement treaties, and several environmental treaties. The one treaty reported by the Committee, but not acted on by the Senate, was the Convention on the Elimination of All Forms of Discrimination Against Women, which, under the Senate rules, was returned to the Committee calendar at the end of the Congress. The Committee also conducted several hearings on the strategic arms reduction treaty with Russia (the “Moscow Treaty”), which President Bush and Russian President Putin signed in May 2002.

The Committee held dozens of oversight hearings and hearings on presidential nominees. Review of nominations consumed a substantial amount of time during the first session of the Congress because the change in presidential administrations, necessarily, resulted in a large volume of nominations for senior Executive Branch positions. The oversight hearings focused on several topics, most prominently the war on terrorism, non-proliferation, the war in Afghanistan and the effort to rebuild that country, and a possible war in Iraq. The hearings the Committee held in July and August 2002 on the Iraq question were credited with spurring a national debate on United States policy with regard to Iraq.

## 1. DEPARTMENT OF STATE

There were 72 nominations for State Department officials referred to the Committee, of which 61 were confirmed by the Senate. These nominations were for Secretary of State, Deputy Assistant Secretary of State, Deputy Secretary of State for Management and Resources, Legal Adviser, Chief Financial Officer, Director General, Inspector General, Under Secretaries (6), Assistant Secretaries (27), Ambassadors at Large (4), and 28 rank of Ambassador positions.

## 2. AMBASSADORS

During the 107th Congress, 146 nominations for country Ambassadors were referred to the Committee. Of these 146 nominations, 130 were confirmed by the Senate.

## 3. OTHERS

The Committee received 14 nominations for officials at the Agency for International Development, two for the Peace Corps, one to the Trade and Development Agency, and 10 nominations to various international banks. The Senate confirmed 26 of these nominations.

Nominations for membership on boards and commissions were received as follows: Advisory Board for Cuba Broadcasting (1); Broadcasting Board of Governors (9); Overseas Private Investment Corporation (12); African Development Foundation (2); Inter-Amer-

During the 107th Congress, the full Committee and its subcommittees held a total of 180 sessions. These included hearings on legislation, treaties, and nominations, as well as briefings and consultations with officials of the executive branch and non-government witnesses on current foreign policy matters. Members and staff made individual trips abroad and participated in inter-parliamentary conferences to further exercise the legislative oversight responsibilities of the Committee.
