Management activities to maintain or restore fish and wildlife populations and the habitats to support such populations may be carried out within wilderness areas designated by this title and shall include the use of motorized vehicles by the appropriate State agencies, particularly where such agencies deem vehicular access is necessary to maintain water sources constructed to preserve desert bighorn sheep and other wildlife.
