CHAP. 3333.-An Act To amend section sixty-four of the bankruptcy Act.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That clause four of sub-Bankruptey. division B of section sixty-four of said Act is hereby amended so as to work amended. States of America in Congress assembled, That clause four of subread as follows:

"Fourth. Wages due to workmen, clerks, traveling or city salesmen, or servants which have been earned within three months before the date of commencement of proceedings, not to exceed three hundred dollars to each claimant.'

CHAP. 3334.—An Act Releasing the right, title, and interest of the United States to the piece or parcel of land known as the Cuartel lot to the city of Monterey, California.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That all the right, title, and Monterey, Cal. Interest of the United States in the piece or parcel of land known as released to. the Cuartel lot, situated in the city of Monterey, State of California, is hereby released to the said city of Monterey as the successor in interest of the old pueblo of Monterey. That the city of Monterey, Trustee of original California, is hereby designated as the trustee of the original grant made by the Mexican Government of pueblo lands to the pueblo of Monterey, as the successor of said pueblo, to hold the same in trust for the uses and purposes of the original grant, and confirmation is hereby made to said city of said land as patented November nineteenth, eighteen hundred and ninety-one.

CHAP. 3335.—An Act To enable the people of Oklahoma and of the Indian Ter-ritory to form a constitution and State government and be admitted into the Union on an equal footing with the original States; and to enable the people of New Mexico and of Arizona to form a constitution and State government and be admitted into the Union on an equal footing with the original States.
