CHAP. 264.—An Act To accept the cession by the State of Montana of exclusive jurisdiction over the lands embraced within the Glacier National Park, and for other August 22, 1914. [S. 654.]

[Public, No. 177.]

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the provisions of the Park, Mont. Sole jurisdiction of United States over, seventeenth, nineteen hundred and eleven, ceding to the United States over, ceded by Montana. exclusive jurisdiction over the territory embraced within the Glacier National Park, are hereby accepted, and sole and exclusive jurisdiction is hereby assumed by the United States over such territory, saving, however, to the said State the right to serve civil or criminal process within the limits of the aforesaid park in suits or prosecution for or on account of rights acquired, obligations incurred, or crimes committed in said State but outside of said park, and saving further to the said State the right to tax persons and corporations, their franchises and property, on the lands included in said park. All the laws applicable to places under the sole and exclusive jurisdiction of the United States shall have force and effect in said park. tives from justice taking refuge in said park shall be subject to the
