19 The parties request and stipulate that the time beginning
20 October 4, 2007, and extending through November 30, 2007 and
21 stipulate should be excluded from the calculation of time under
22 the Speedy Trial Act. The requested date for the next status
23 conference is November 30, 2007 at 10:00 a.m. Defendants Alice
24 Peterson, Jamel Gill and Javon Gill and the United States submit
25 that the ends of justice are served by the Court excluding such
26 time, in order to permit the counsel a reasonable time for
27 effective preparation, taking into account the exercise of due
28 diligence. 18 U.S.C. § 3161(h) (8) (B) (iv). In particular, the

1 parties are working toward a resolution to the case and need more
2 time to evaluate the evidence and negotiate disputed issues. The
3 parties stipulate and agree that the interests of justice served
4 by granting this continuance outweigh the best interests of the
5 public and the defendant in a speedy trial. 18 U.S.C. §
6 3161(h)(8)(A) and local code T-4. The Court on October 3, 2007
7 ordered a T-4 exclusion of time until November 16, 2007.
