If the Government exercises this option, the extended contract shall be considered to include this clause, except, the total duration of the contract may not exceed five (5) years as a result of, and including, any extension(s) added under this clause. EXTENSION OF CONTRACT TERM: At the request of the Government, the term of any contract resulting from this solicitation may be extended for such period of time as may be mutually agreeable to the GPO and the contractor.

ECONOMIC PRICE ADJUSTMENT: The pricing under this contract shall be adjusted in accordance with this clause, provided that in no event will any pricing adjustment be made that would exceed the maximum permissible under any law in effect at the time of the adjustment. There will be no adjustment for orders placed during the first period specified below. Pricing will thereafter be eligible for adjustment during the second and any succeeding performance period(s). For each performance period after the first, a percentage figure will be calculated as described below and that figure will be the economic price adjustment for that entire next period. Pricing adjustments under this clause are not applicable to reimbursable postage or transportation costs, or to paper, if paper prices are subject to adjustment by separate clause elsewhere in this contract.

For the purpose of this clause, performance under this contract will be divided into successive periods. The first period will extend from Date of Award to March 31, 2019, and the second and any succeeding period(s) will extend for 12 months from the end of the last preceding period, except that the length of the final period may vary. The first day of the second and any succeeding period(s) will be the effective date of the economic price adjustment for that period.

Pricing adjustments in accordance with this clause will be based on changes in the seasonally adjusted "Consumer Price Index For All Urban Consumers – Commodities less Food" (Index) published monthly in the CPI Detailed Report by the U.S. Department of Labor, Bureau of Labor Statistics.

The economic price adjustment will be the percentage difference between Index averages as specified in this paragraph. An index called the variable index will be calculated by averaging the monthly Indexes from the 12-month interval ending three (3) months prior to the beginning of the period being considered for adjustment. This average is then compared to the average of the monthly Indexes for the 12-month interval ending December 31, 2017, called the base index. The percentage change (plus or minus) of the variable index from the base index will be the economic price adjustment for the period being considered for adjustment.

The Government will notify the contractor by contract modification specifying the percentage increase or decrease to be applied to invoices for orders placed during the period indicated. All print orders issued hereunder are subject to the terms and conditions of the contract. The contract shall control in the event of conflict with any print order. A print order shall be "issued", upon notification by the Government for purposes of the contract when it is electronically transmitted or otherwise physically furnished to contractor in conformance with the schedule.

REQUIREMENTS: This is a requirements contract for the items and for the period specified herein. Shipment/delivery of items or performance of work shall be made only as authorized by orders issued in accordance with the clause entitled "ORDERING." The quantities of items specified herein are estimates only, and are not purchased hereby. Except as may be otherwise provided in this contract, if the Government's requirements for the items set forth herein do not result in orders in the amounts or quantities described as "estimated," it shall not constitute the basis for an equitable price adjustment under this contract.

PAYMENT: Upon completion of each order, the contractor is required to furnish their billing invoice to the ordering agency for examination and certification as to correctness of billing as applicable to the work performed. Contractor to submit billing to the ordering agency as specified on the print order.

The ordering agency is required to return the signed billing certification to the contractor within five (5) workdays of receipt thereof.

After examination and certification by the ordering agency, contractor must submit his invoice to GPO.

SECTION 2 - SPECIFICATIONS

SCOPE: These specifications cover the production of business cards requiring such operations as on-line ordering; printing in four color process plus black, satin aqueous coating; packing; and distribution.

TITLE: Colorado Army National Guard (COARNG) Business Cards.

FREQUENCY OF ORDERS: Approximately 100 orders per year.

QUANTITY: 500 to 1,000 cards per individual name and approximately 5 to 10 names per order.

TRIM SIZE: 3-1/2 x 2".

NUMBER OF PAGES: Face and back.

GOVERNMENT TO FURNISH: Four to six images will be made available as electronic media for online ordering as furnished below:

Platform: PC

Storage Media: Digital File Transfer Protocol (FTP) or via email.

Software: Converted Photoshop images into high quality JPG, current versions.

All platform system and software upgrades (for specified applications) that may occur during the term of the contract must be supported by the contractor.

Fonts: All printer and screen fonts will be embedded in base artwork.

The contractor is cautioned that furnished fonts are the property of the Government and/or its originator. All furnished fonts are to be eliminated from the contractor's archive immediately after completion of the contract.

Additional

Information: No prepress functions (e.g., color correction, UCR/GCR, sharpening or other image enhancement) or procedures have been applied to supplied images. Colors will be provided in CYMK and RGB. Files will be furnished in native application and/or PDF format. All necessary scans and graphics will be properly linked and in final position. CYMK to be used for color identification.

> Identification markings such as register marks, commercial identification marks of any kind, etc., carried in the electronic files, must not print on finished product.

CONTRACTOR TO FURNISH: All materials and operations, other than those listed under "GOVERNMENT TO FURNISH," necessary to produce the products in accordance with these specifications.

The contractor must be able to accept files electronically via a contractor-hosted FTP server. Appropriate log-on instructions and protocol must be provided at time of award. The contractor must provide necessary security for the FTP, which at a minimum, must have a unique user ID and password.

ELECTRONIC PREPRESS: Prior to image processing, the contractor shall perform a basic check (preflight) of the furnished media and publishing files to assure correct output of the required reproduction image. Any errors other than those described below, media damage, or data corruption that might interfere with proper file image processing must be reported to the Contracting Officer and ordering agency immediately upon discovery.

COARNG Business Cards Program 1818-S (3/19)

The contractor will not receive additional compensation or time for common errors associated with the output of files. Common errors include, but are not limited to:

- color issues and shifts (RGB color data, no spot colors, loss of black plate)
- page integrity (text reflow or type substitution)
- errors associated with embedded graphics
- missing prepress features (e.g., bleeds, trim marks)
- loss of text characters from graphic elements
- defining proper file output selection for the imaging device being used.

The contractor shall create/extend bleeds, create or alter any necessary trapping, set proper screen angles and frequency, define proper file output selection for the imaging device being utilized, and ensure that the black type is a solid black, NOT a process build. Contractor will convert all submitted color to four color process. Furnished files must be imaged as necessary to meet the assigned quality level.

Prior to making revisions, the contractor shall copy the furnished files and make all changes to the copy.

ON-LINE ORDERING: NOTE: The responsible low bidder will have 30 calendar days from the date of award to provide a web-based on-line ordering system that meets the Department's requirements.

The contractor must provide a web-based on-line ordering system site that permits authorized Colorado Army National Guard (COARNG) personnel to order business cards. The system must provide a method of order tracking by requestor. The web-based system must be secure (password protected) so that only authorized personnel can order business cards and must provide a separate page/site so that only authorized personnel (Program Manager) can approve submitted business cards. The program manager will provide a list of authorized users and passwords.

The system must have a user-friendly web page so users can be utilized by the agency to input recruiter's contact information. The web page must have reference information and instructions for each input block as follows: Rank and Name, Title, Office Number, Cell Phone, Email, Street Address, City, State, and Zip Code. The web page must have the capability to display each business card as it will appear once printed after contact information is entered. The user must be able to change or correct information displayed in the on-line visual proof prior to submission to the agency manager for approval to print.

Once the user submits an order for approval by the agency manager, the system must generate an email to the original requestor indicating the order has been sent to the manager for approval. The system must concurrently generate an email to the manager indicating that an order is awaiting approval. The manager must be able to approve or disapprove each request, and approve or disapprove a group of contact entries per print order. After the program manager approves a specific group of contact entries with a corresponding print order, the web-based system must provide a total count of contact entries approved in that group with associated print order and generate a spreadsheet that contains requestor names, recipient's names, confirmation date and number of contact names associated with each print order submitted. The program manager will forward this list to the user to show when and what was ordered. The web-based system must provide an option for users to retrieve a previous order from a "history or look-up file" using a name or confirmation number from a previous order. If a change is necessary, the user must be able to make the change to the previous order and then submit as a new order.

The contractor may not proceed with production until each order has been approved or disapproved online by the manager. Once the cards have been printed and shipped, the web-based system must generate an email containing a shipping list of all cards printed on a specific print order (information to include name of recipient, date shipped, estimated delivery date and a tracking number) to all the authorized users.

STOCK/PAPER: The specifications of all paper furnished must be in accordance with those listed herein or listed for the corresponding JCP Code numbers in the "Government Paper Specification Standards No. 12" dated March 2011. https://www.gpo.gov/docs/default-source/forms-and-standards-files-for-vendors/vol_12.pdf

All paper used in an order must be of a uniform shade.

Coated One Side Cover (CIS), White, Basis Size 20 X 26", 15 pt., JCP Code* L70.

PRINTING: Business cards print face and back, head to head, four color process or duotone colors. After printing, flood coat face only with a clear, non-yellowing, satin-finish aqueous coating. The coating must be evenly applied with no trapped foreign particles or air bubbles.

At contractor's option, the product may be produced via conventional offset or digital printing provided that Quality Level 3 standards are maintained. Final output must be wet ink, pigment-based with a minimum of 175 line screen. Dry ink/toner and inkjet printing are not acceptable. Output must be at a minimum resolution of 2400 x 2400 dpi plus a RIP that provides an option for high quality color matching such as Device Links Technology and/or ICC Profiles. Resolution that is enhanced or simulated by software will not be acceptable.

Prior to award, contractor may be required to provide information related to specific equipment that will be used for production.

NOTE: The GPO imprint must not print on final product.

MARGINS: Full bleeds on face and back.

FINISHING: Trim four sides.

PACKING: Cards will be boxed in units 500 or 1,000. Place one card on the top of the box and then shrink film wrap the box before placing it in a suitable outer shipping container. All shipments that fill less than a shipping container must be packaged with materials of sufficient strength and durability and in such a manner that will guarantee that the product will not be damaged and the package will not crush, open or split during delivery.

LABELING AND MARKING: Contractor to download the GPO Form 905, R. 7-15 "Labeling and Marking Specifications" form, located at https://www.gpo.gov/docs/default-source/forms-and-standards-files-for-vendors/gpo905.pdf, fill in appropriate blanks, and attach to shipping containers.

DISTRIBUTION: Ship f.o.b. destination to approximately 5 to 15 different addresses within Colorado, with an average of 10 destinations per print order of 500 or 1,000 cards per destination. The cards will ship to the addresses printed on each business card.

The contractor must use the most expedient traceable method of delivery on each print order and provide proof of delivery by means of a signed receipt when requested by the department. Occasional orders may require the contractor to re-ship all or part of the order to an additional address or addresses due to incorrect addresses provided by the department, refusal of shipments at the original address, and for various other reasons. Upon submission of adequate documentation, the contractor will be reimbursed for additional shipping costs via a GPO-issued contract modification for each affected print order. Otherwise, all shipping expenses are borne by the contractor.

Upon completion of each order, contractor must notify the ordering agency (on the same day the order delivers) via email to the address indicated on the print order. The subject line of the email shall be "Distribution Notice for Program 1818-S, Print Order XXXXX, Jacket Number XXX-XXX." The notice must provide all applicable tracking numbers, delivery methods, and title of product. Contractor must be able to provide copies of all delivery receipts upon agency request.

All expenses incidental to picking up and returning materials (if applicable), submitting proofs and paper samples, and furnishing sample copies must be borne by the contractor.

SCHEDULE: Items to be furnished under the contract shall be ordered by the issuance of print orders (form 2511) by the Government. One print order may be issued monthly for that period, and the contractor will voucher/invoice on a monthly basis (see "PAYMENT" hereinafter). Multiple items will be placed during this monthly period; the schedule specified pertains to the placement of these individual work orders. Orders may be issued during the contract period plus for such additional period(s) as the contract is extended. All print orders issued hereunder are subject to the terms and conditions of the contract.

Adherence to this schedule must be maintained. Contractor must not start production of any job prior to receipt of the individual print order (GPO Form 2511). A signed print order will be facsimiled or emailed to the contractor at the beginning of each month.

The following schedule begins the workday after receipt of the print order. Workdays are Monday through Friday, exclusive of Federal holidays.

The contractor must make complete production and delivery of all orders within 4 to 5 workdays. The majority of orders will be delivered within 5 days. Rush order of 1-3 names per order will be the exception and will require delivery within 3-workdays from the order being requested.

The ship/delivery date indicated on the print order is the date products ordered for delivery f.o.b. destination must be delivered to the destinations specified.

ERROR CARD PROCESSING: The program manager will notify the contractor as soon as possible, but no later than 90 days after receipt of an order by the original requester, to reprint cards that are determined to be rejectable due to typesetting or other discrepancies that are the result of contractor error. The contractor must have the capability to receive faxed or email notifications of rejected orders. These cards will be reprinted and shipped at no additional cost to the Government no later than 72 hours from initial notification by the department.

To expedite notification for cards containing errors caused by the contractor, the program manager will forward by use of fax or e- mail a GPO Form 907 (Non-Compliance/Change Report) directly to the contractor with a copy to the Denver GPO Regional Printing Procurement Office. When warranted, the department will forward a GPO Form 907 directly to the GPO.

LOST OR UNDELIVERED CARD PROCESSING: Upon notification from the agency, the contractor will initiate a tracer action for each order reported to be lost or undelivered. The contractor will provide a status report to the program manager via fax or email within 24 hours from initial notification. To expedite this process, the department will forward by use of fax or email, a GPO Form 907 directly to the contractor with an information copy to the Denver GPO Regional Printing Procurement Office; infodenver@gpo.gov. The contractor must have capability to receive faxed or email notifications of lost or undelivered orders.

The contractor will obtain a status report from the traceable delivery source used. If the contractor is unable to determine the status of these cards with the traceable service within 24 hours after notification, then these cards will be reprinted and shipped at no additional expense to the Government within 72 hours from initial notification.

If contractor is able to locate lost or undelivered orders within 24 hours after initial notification, then the contractor must make arrangements (with the service used) to ship the order to its destination within 72 hours. It is the contractor's responsibility to recoup any expenses involved with reprinting an order and delivery of the order from the service used.

Note: Accurate and timely tracing of orders is considered an integral part of these contract specifications and the contractor may be held in default for failure to provide this information as specified.
