It includes for each Government department and agency the text of proposed appropriations language, budget schedules for each account, new legislative proposals, explanations of the work to be performed and the funds needed, and proposed general provisions applicable to the appropriations of entire agencies or groups of agencies.

*Budget CD-ROM.* The CD-ROM contains the full content of the printed budget documents and many supporting documents for the budget in PDF format. Software to search, display, and print PDF files is provided. A number of budget tables are provided in spreadsheet format. These budget tables include Historical Tables that provide data on budget receipts, outlays, surpluses or deficits, and Federal debt over a time period extending from FY 1942 or earlier to FY 2024.
