Software to search, display, and print PDF files is provided. A number of budget tables are provided in spreadsheet format. These budget tables include Historical Tables that provide data on budget receipts, outlays, surpluses or deficits, and Federal debt over a time period extending from FY 1942 or earlier to FY 2024.
