## Introduction

The Submission Form Field Definitions document describes the data maintained and utilized for Congressionally Mandated Reports and the submission thereof to GPO. It describes the type of data maintained in each field and the accepted values for those fields. Additionally, where only specified values are accepted, this document defines those values.

Congressional Mandated Reports submission portal users should use this document to identify correct information to determine appropriate values to use when preparing to submit reports to GPO.
