This is Amendment No. 1. The specifications in our invitation for bids on Program 744-S, scheduled for opening at 11:00 AM on May 22, 2024, are amended as follows:

Bid Opening date does not change.

On page 11 of 21, under Section 2 – PRIOR TO PRODUCTION SAMPLES:

Delete:

NOTE: All Prior to Production samples must deliver via traceable means. Approval/disapproval of samples will come from GPO.

Insert:

NOTE: All Prior to Production samples must deliver via traceable means. Approval/disapproval of samples will come from both GPO and Census in a single email.

On page 13 of 21, under Section 2 – BINDING:

Delete:

Stitches must be centered.

After saddle-stitching, some questionnaires, re-fold to $8-1/2 \times 5-1/2$ ", with title page facing out.

On page 16 of 21, under Section 2 – BINDING:

Delete:

All priors and/or proofs must deliver via traceable means. Approval/disapproval of priors and/or proofs will come from GPO. When applicable, all furnished electronic media must be returned with proofs.

Insert:

All priors and/or proofs must deliver via traceable means. When applicable, all furnished electronic media must be returned with proofs. Approval/disapproval of priors and/or proofs will come from both GPO and Census in a single email.

On page 18 of 21, under Section 3 – DETERMINATION OF AWARD:

Delete:

Sending one (1) Government representative from the Washington, DC, area for the press sheet and binding inspections on approximately 75% of all orders issued, lasting approximately one (1) workday each.





Insert:

Sending one (1) Government representative from the Washington, DC, area for the press sheet and binding inspections, ordered together on approximately 75% of all orders issued, lasting approximately two (2) workdays per order, when required.

On page 18 of 21, under Section 3 – DETERMINATION OF AWARD:

Delete:

Sending two (2) On-Site Government Representatives from the Jeffersonville, IN, area for Quality Control Monitoring on all orders for approximately 15 workdays per print order.

Insert:

Sending one (1) or two (2) On-Site Government Representatives from the Jeffersonville, IN, area for Quality Control Monitoring on all orders for approximately 15 workdays per print order.

All other specifications remain the same.
