**A BILL**

To validate conveyances of certain lands in the State of California that form part of the right-of-way granted by the United States to the Central Pacific Railway Company.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Railroad Right-of-Way  
3 Conveyance Validation Act”.

4 **SEC. 2. VALIDATION OF CONVEYANCES.**

5 Except as provided in section 5, the conveyances de-  
6 scribed in section 3 (involving certain lands in Nevada  
7 County, State of California) and section 4 (involving cer-  
8 tain lands in San Joaquin County, State of California)  
9 concerning lands that form parts of the right-of-way  
10 granted by the United States to the Central Pacific Rail-  
11 way Company in the Act entitled “An Act to aid in the  
12 Construction of a Railroad and Telegraph Line from the  
13 Missouri River to the Pacific Ocean, and to secure to the  
14 Government the Use of the same for Postal, Military, and  
15 Other Purposes”, approved July 1, 1862 (12 Stat. 489),  
16 hereby are legalized, validated, and confirmed, as far as  
17 any interest of the United States in such lands is con-  
18 cerned, with the same force and effect as if the land in-  
19 volved in each such conveyance had been held, on the date  
20 of such conveyance, under absolute fee simple title by the  
21 grantor of such land.

22   **SEC. 5. LIMITATIONS ON VALIDATION OF CONVEYANCES.**

23       ~~Nothing~~ (a) *SCOPE.*—*Nothing* in this Act shall be  
24   construed to—

1           (1) diminish the right-of-way referred to in sec-  
2           tion 2 to a width of less than fifty feet on each side  
3           of the center of the main track or tracks maintained  
4           by the Southern Pacific Transportation Company on  
5           the date of enactment of this Act;

6           (2) legalize, validate, or confirm, with respect to  
7           any land that is the subject of a conveyance referred  
8           to in section 3 or 4, any right or title to, or interest  
9           in, such land arising out of adverse possession, pre-  
10          scription, or abandonment, and not confirmed by  
11          such conveyance; or

12          ~~(3) diminish any of the right, title, or interest~~  
13          ~~of the United States with respect to oil, gas, and~~  
14          ~~other minerals, or with respect to prospecting for or~~  
15          ~~mining or removal thereof, in any of the lands that~~  
16          ~~are the subject of a conveyance referred to in section~~  
17          ~~3 or 4.~~

18          **(b) MINERALS.**—(1) *The United States hereby reserves*  
19          *any federally-owned minerals that may exist in land that*  
20          *is conveyed pursuant to section 2 of this Act, including the*  
21          *right of the United States, its assignees or lessees, to enter*  
22          *upon and utilize as much of the surface of said land as*  
23          *is necessary to remove minerals under the laws of the Unit-*  
24          *ed States.*

1       (2) Any and all minerals reserved by paragraph (1)  
2 are hereby withdrawn from all forms of entry, appropria-  
3 tion, and patent under the mining, mineral leasing, and  
4 geothermal leasing laws of the United States.
