## A BILL

To provide for the conservation, management, or study of  
certain rivers, parks, trails, and historic sites, and for  
other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

### 3                   **TITLE I—RIVERS**

#### 4       **SEC. 101. SHORT TITLE.**

5           This title may be cited as the “West Virginia Rivers  
6 Conservation Act of 1993”.

#### 7       **SEC. 102. NEW RIVER GORGE NATIONAL RIVER.**

8           Section 1101 of the National Parks and Recreation  
9 Act of 1978 (16 U.S.C. 460m–15) is amended by striking

1 out “NERI-80,023, dated January 1987” and inserting  
2 “NERI-80,028, dated January 1993”.

3 **SEC. 103. GAULEY RIVER NATIONAL RECREATION AREA.**

4 Section 201(b) of the West Virginia National Interest  
5 River Conservation Act of 1987 (16 U.S.C. 460ww(b)) is  
6 amended by striking out “NRA-GR/20,000A and dated  
7 July 1987” and inserting “GARI-80,001 and dated Janu-  
8 ary 1993”.

9 **SEC. 104. BLUESTONE NATIONAL SCENIC RIVER.**

10 Section 3(a)(65) of the Wild and Scenic Rivers Act  
11 (16 U.S.C. 1274(a)(65)) is amended by striking out  
12 “WSR-BLU/20,000, and dated January 1987” and in-  
13 serting “BLUE-80,004, and dated January 1993”.

14 **SEC. 105. DESIGNATION OF UPPER NEW RIVER, WEST VIR-**  
15 **GINIA.**

16 Section 3(a) of the Wild and Scenic Rivers Act (16  
17 U.S.C. 1274(a)) is amended by adding the following new  
18 paragraph at the end:

19 “( ) UPPER NEW RIVER, WEST VIRGINIA.—(A) The  
20 segment in Summers County, West Virginia, from the  
21 West Virginia-Virginia State line downstream for approxi-  
22 mately 14.5 miles as depicted on the boundary map enti-  
23 tled ‘Upper New Wild and Scenic River’, numbered UPNE  
24 80,000 and dated July 1993; to be administered by the  
25 Secretary of the Interior as a scenic river.

1       “(B) The acreage limitation set forth in subsection  
2 (b) shall not apply to the segment designated under this  
3 paragraph. Nothing in this Act shall preclude the improve-  
4 ment of any existing road or right-of-way within the  
5 boundaries of the segment designated under this para-  
6 graph.

7       “(C) Jurisdiction over all lands and improvements on  
8 such lands owned by the United States within the bound-  
9 aries of the segment designated under this paragraph is  
10 hereby transferred without reimbursement to the adminis-  
11 trative jurisdiction of the Secretary of the Interior, subject  
12 to the lease in effect on the date of enactment of this para-  
13 graph (or renewed thereafter) between the United States  
14 and the State of West Virginia with respect to the  
15 Bluestone Wildlife Management Area.

16       “(D) Nothing in this Act shall affect the management  
17 by the State of West Virginia of hunting and fishing with-  
18 in the segment designated under this paragraph. Nothing  
19 in this Act shall affect or impair the management by the  
20 State of West Virginia of other wildlife activities in the  
21 Bluestone Wildlife Management Area to the extent per-  
22 mitted in the lease agreement as in effect on the date of  
23 enactment of this paragraph, and if the State of West Vir-  
24 ginia so requests, the Secretary shall renew such lease  
25 agreement with the same terms and conditions as con-

1 tained in such lease agreement on the date of enactment  
2 of this paragraph under which such State management  
3 shall be continued pursuant to such renewal. If requested  
4 to do so by the State of West Virginia, or as provided  
5 in such lease agreement, the Secretary may terminate or  
6 modify the lease and assume administrative authority over  
7 all or part of the areas concerned.

8 “(E) Nothing in the designation of the segment re-  
9 ferred to in this paragraph shall affect or impair the man-  
10 agement of the Bluestone project or the authority of any  
11 department, agency, or instrumentality of the United  
12 States to carry out the project purposes of that project.”.

13 **SEC. 106. DESIGNATION OF ELK RIVER AS A STUDY RIVER.**

14 The Secretary of the Interior shall conduct a study  
15 of the segment of the Elk River, West Virginia, from the  
16 Webster-Randolph County line to Centralia in Braxton  
17 County, to determine its eligibility and suitability as ei-  
18 ther—

19 (1) a component of the national wild and scenic  
20 rivers system,

21 (2) a unit of the National Park System as a na-  
22 tional river, or

23 (3) a unit of the National Park System as a na-  
24 tional recreation area.

1 The Secretary shall submit a report containing the results  
2 of such study to the Committee on Natural Resources of  
3 the United States House of Representatives and to the  
4 Committee on Energy and Natural Resources of the Unit-  
5 ed States Senate within 3 years after the enactment of  
6 this Act. Nothing in this section shall affect or impair the  
7 management of the Sutton project or the authority of any  
8 department, agency, or instrumentality of the United  
9 States to carry out the project purposes of that project  
10 as of the date of enactment of this section. In conducting  
11 the study authorized by this section, the Secretary shall  
12 consult with the West Virginia Division of Tourism and  
13 Parks and the West Virginia Division of Environmental  
14 Protection.

15 **SEC. 107. CONSOLIDATED MANAGEMENT.**

16 In order to achieve the maximum economy and effi-  
17 ciency of operations in the administration of the segment  
18 of the New River designated pursuant to section 205, the  
19 Secretary of the Interior shall consolidate offices and per-  
20 sonnel administering such segment with offices and per-  
21 sonnel administering the New River Gorge National River,  
22 the Gauley River National Recreation Area, and the  
23 Bluestone National Scenic River to the extent practicable,  
24 and shall utilize facilities of the New River Gorge National  
25 River to the extent practicable.

1 **SEC. 108. MISCELLANEOUS PROVISIONS.**

2 (a) NEW RIVER CONFORMING AMENDMENTS.—Title  
3 XI of the National Parks and Recreation Act of 1978 (16  
4 U.S.C. 460m–15 and following) is amended by adding the  
5 following new section at the end thereof:

6 **“SEC. 1117. APPLICABLE PROVISIONS OF OTHER LAW.**

7 “(a) COOPERATIVE AGREEMENTS.—The provisions  
8 of section 202(e)(1) of the West Virginia National Interest  
9 River Conservation Act of 1987 (16 U.S.C. 460ww–  
10 1(e)(1)) shall apply to the New River Gorge National  
11 River in the same manner and to the same extent as such  
12 provisions apply to the Gauley River National Recreation  
13 Area.

14 “(b) REMNANT LANDS.—The provisions of the sec-  
15 ond sentence of section 203(a) of the West Virginia Na-  
16 tional Interest River Conservation Act of 1987 (16 U.S.C.  
17 460ww–2(a)) shall apply to tracts of land partially within  
18 the boundaries of the New River Gorge National River in  
19 the same manner and to the same extent as such provi-  
20 sions apply to tracts of land only partially within the  
21 Gauley River National Recreation Area.”.

22 (b) BLUESTONE RIVER CONFORMING AMEND-  
23 MENTS.—Section 3(a)(65) of the Wild and Scenic Rivers  
24 Act (16 U.S.C. 1274(a)(65)) is amended by striking  
25 “leases” in the fifth sentence and inserting in lieu thereof  
26 “the lease” and in the seventh sentence by striking “such

1 management may be continued pursuant to renewal of  
2 such lease agreement. If requested to do so by the State  
3 of West Virginia, or as provided in such lease agreement,  
4 the Secretary may terminate such leases and assume ad-  
5 ministrative authority over the areas concerned.” and in-  
6 serting in lieu thereof the following: “if the State of West  
7 Virginia so requests, the Secretary shall renew such lease  
8 agreement with the same terms and conditions as con-  
9 tained in such lease agreement on the date of enactment  
10 of this paragraph under which such State management  
11 shall be continued pursuant to such renewal. If requested  
12 to do so by the State of West Virginia, or as provided  
13 in such lease agreement, the Secretary may terminate or  
14 modify the lease and assume administrative authority over  
15 all or part of the areas concerned.”.

16 **SEC. 109. GAULEY ACCESS.**

17 Section 202(e) of the West Virginia National Interest  
18 River Conservation Act of 1987 (16 U.S.C. 460ww-1(e))  
19 is amended by adding the following new paragraph at the  
20 end thereof:

21 “(4) ACCESS TO RIVER.—Within 90 days after the  
22 date of enactment of this subsection, the Secretary shall  
23 submit a report to the Committee on Natural Resources  
24 of the House of Representatives and to the Committee on  
25 Energy and Natural Resources of the Senate setting forth

1 a plan to provide river access for noncommercial rec-  
2 reational users within the Gauley River National Recre-  
3 ation Area. The plan shall provide that such access shall  
4 utilize existing public roads and rights-of-way to the maxi-  
5 mum extent feasible and shall be limited to providing ac-  
6 cess for such noncommercial users.”.

7 **SEC. 110. VISITOR CENTER.**

8       The Secretary of the Interior is authorized to con-  
9 struct a visitor center and such other related facilities as  
10 may be deemed necessary to facilitate visitor understand-  
11 ing and enjoyment of the New River Gorge National River  
12 and the Gauley River National Recreation Area in the vi-  
13 cinity of the confluence of the New and Gauley Rivers.  
14 Such center and related facilities are authorized to be con-  
15 structed at a site outside of the boundary of the New River  
16 Gorge National River or the Gauley River National Recre-  
17 ation Area unless a suitable site is available within the  
18 boundaries of either unit.

19 **SEC. 111. EXTENSION.**

20       For a 5-year period following the date of enactment  
21 of this Act, the provisions of the Wild and Scenic Rivers  
22 Act applicable to river segments designated for study for  
23 potential addition to the wild and scenic rivers system  
24 under section 5(b) of that Act shall apply to those seg-  
25 ments of the Bluestone and Meadow Rivers which were

1 found eligible in the studies completed by the National  
2 Park Service in August 1983 but which were not des-  
3 ignated by the West Virginia National Interest River Con-  
4 servation Act of 1987 as part of the Bluestone National  
5 Scenic River or as part of the Gauley River National  
6 Recreation Area, as the case may be.

7 **SEC. 112. BLUESTONE RIVER PUBLIC ACCESS.**

8 Section 3(a)(65) of the Wild and Scenic Rivers Act  
9 (16 U.S.C 1271 and following) is amended by adding the  
10 following at the end thereof: “In order to provide reason-  
11 able public access and vehicle parking for public use and  
12 enjoyment of the river designated by this paragraph, con-  
13 sistent with the preservation and enhancement of the nat-  
14 ural and scenic values of such river, the Secretary may,  
15 with the consent of the owner thereof, negotiate a memo-  
16 randum of understanding or cooperative agreement, or ac-  
17 quire such lands or interests in such lands, or both, as  
18 may be necessary to allow public access to the Bluestone  
19 River and to provide, outside the boundary of the scenic  
20 river, parking and related facilities in the vicinity of the  
21 area known as Eads Mill.”.

22 **SEC. 113. GAULEY RIVER BOUNDARY MODIFICATION.**

23 Section 205(c) of the West Virginia National Interest  
24 River Conservation Act of 1987 (16 U.S.C 460ww-4(c))  
25 is amended by adding the following at the end thereof:

1 “If project construction is not commenced within the time  
2 required in such license, or if such license is surrendered  
3 at any time, such boundary modification shall cease to  
4 have any force and effect.”.

## 5 **TITLE II—TRAILS**

### 6 **SEC. 201. GREAT WESTERN SCENIC TRAIL.**

7 Section 5(c) of the National Trails System Act (16  
8 U.S.C. 1244(c)) is amended by adding at the end the fol-  
9 lowing new paragraph:

10 “( ) The Great Western Scenic Trail, a system of  
11 trails to accommodate a variety of travel users in a cor-  
12 ridor of approximately 3,100 miles in length extending  
13 from the Arizona-Mexico border to the Idaho-Montana-  
14 Canada border, following the approximate route depicted  
15 on the map identified as ‘Great Western Trail Corridor,  
16 1988’, which shall be on file and available for public in-  
17 spection in the Office of the Chief of the Forest Service,  
18 United States Department of Agriculture. The trail study  
19 shall be conducted by the Forest Service in consultation  
20 with the Department of the Interior. The Secretary of Ag-  
21 riculture shall examine in such study the appropriateness  
22 of motorized trail use along the trail.”.

**TITLE III—PARKS****2 SEC. 301. PROHIBITION OF COMMERCIAL VEHICLES.**

3 (a) IN GENERAL.—Effective at noon on July 30,  
4 2000, the use of Highway 209 within the Delaware Water  
5 Gap National Recreation Area by commercial vehicles,  
6 when such use is in no way connected with the operation  
7 of the recreation area, is prohibited except pursuant to  
8 a permit issued in accordance with regulations promul-  
9 gated by the Secretary of the Interior. Such regulations  
10 shall permit such use only in emergency situations or for  
11 access to non-Federal land within or contiguous to the  
12 recreation area.

13 (b) CONFORMING PROVISIONS.—Subsections (1)  
14 through (3) of the third undesignated paragraph under  
15 the heading “ADMINISTRATIVE PROVISIONS” in  
16 chapter VII of title I of Public Law 98–63 (97 Stat. 329),  
17 as amended, are repealed effective on the date referred  
18 to in subsection (a) of this section. Pending such effective  
19 date, the Secretary of the Interior shall collect and utilize  
20 a commercial use fee from commercial vehicles in accord-  
21 ance with such subsections, and authority to so collect and  
22 utilize such fees shall continue in effect from the date of  
23 the enactment of this Act through July 30, 2000. Such  
24 fees shall reflect costs of collection but shall not exceed  
25 \$25 per vehicle.

1 (c) BOUNDARY MODIFICATION.—Section 2(a) of the  
2 Act of September 1, 1965 (79 Stat. 612; 16 U.S.C. 460o–  
3 1(a)), establishing the Delaware Water Gap National  
4 Recreation Area is amended by striking “as generally de-  
5 picted on the drawing entitled ‘Proposed Tocks Island Na-  
6 tional Recreation Area’ dated and numbered September  
7 1962, NRA–TI–7100, which drawing is on file” and in-  
8 serting “as generally depicted on the map entitled ‘Dela-  
9 ware Water Gap National Recreation Area’ dated Novem-  
10 ber 1991 and numbered DWGNRA–620/80,900A’ which  
11 shall be on file”.

12 **SEC. 302. CUMBERLAND GAP NATIONAL HISTORICAL PARK.**

13 (a) REMOVAL OF RESTRICTIONS.—The first section  
14 of the Act of June 11, 1940, entitled “An Act to provide  
15 for the establishment of the Cumberland Gap National  
16 Historical Park in Tennessee, Kentucky, and Virginia”  
17 (54 Stat. 262; 16 U.S.C. 261 and following) is amended  
18 by striking out everything after the words “Cumberland  
19 Gap National Historical Park” and inserting a period.

20 (b) USE OF APPROPRIATED FUNDS.—Section 3 of  
21 such Act (16 U.S.C. 263) is amended by inserting “or  
22 with funds that may be from time to time appropriated  
23 for the purpose,” after “funds,”.

24 **SEC. 303. REVERE BEACH, MASSACHUSETTS.**

25 (a) FINDINGS.—The Congress finds that—

1           (1) Revere Beach played an important historic  
2           role as a public beach and park set aside for public  
3           leisure and recreation;

4           (2) Revere Beach represents a valuable example  
5           of the social and cultural aspects of early 20th cen-  
6           tury American working class history;

7           (3) original structures and public buildings of  
8           Revere Beach remain to be preserved and inter-  
9           preted;

10          (4) Revere Beach is located within easy access  
11          of a large urban population center and within reach  
12          of tourists visiting the historic city of Boston; and

13          (5) given the interest by organized groups and  
14          local and State governments in the preservation of  
15          Revere Beach, a coordinated evaluation should be  
16          conducted to consider options for preserving the his-  
17          torical, cultural, natural and recreational resources  
18          of Revere Beach.

19          (b) STUDY.—The Secretary of the Interior (herein-  
20          after in this section referred to as the “Secretary”) shall  
21          conduct a study to identify potential means to preserve  
22          and interpret Revere Beach. As part of the study, the Sec-  
23          retary shall propose alternatives for cooperation in the  
24          preservation and interpretation of Revere Beach, including  
25          providing recommendations on the suitability and feasibil-

1 ity of establishing Revere Beach as a unit of the National  
2 Park System.

3 (c) CONTENTS OF STUDY.—The study of the Sec-  
4 retary shall contain, but not be limited to, findings with  
5 respect to—

6 (1) the role played by Revere Beach in the  
7 processes in industrialization, urbanization, and im-  
8 migration;

9 (2) the historical, cultural, natural, and outdoor  
10 recreational values of Revere Beach;

11 (3) the types of Federal, State, and local pro-  
12 grams that are available to preserve, develop, and  
13 make accessible Revere Beach for public use;

14 (4) the use of, and coordination with, Federal,  
15 State, and local programs to manage in the public  
16 interest the historical, cultural, natural, and rec-  
17 reational resources of Revere Beach; and

18 (5) the possible kinds and general intensities of  
19 development, including a visitor facility with suffi-  
20 cient space to accommodate exhibits and information  
21 regarding the history of Revere Beach, that would  
22 be associated with public enjoyment and use of Re-  
23 vere Beach, including general location and antici-  
24 pated costs.

1 (d) CONGRESSIONAL REVIEW.—The Secretary shall  
2 transmit the study to the Committee on Natural Re-  
3 sources of the House of Representatives and the Commit-  
4 tee on Energy and Natural Resources of the Senate within  
5 12 months after the enactment of this section.

6 (e) CONSULTATION.—In preparing the study under  
7 this section, the Secretary shall consult with the public,  
8 representatives of the city of Revere and the Common-  
9 wealth of Massachusetts, historians, planners, recreation  
10 specialists, and historic preservationists knowledgeable in  
11 American History, historic preservation, and architecture.  
12 The Secretary shall seek expertise from both local and na-  
13 tional organizations.

14 (f) AUTHORIZATION.—There is authorized to be ap-  
15 propriated \$200,000 to carry out this section.

16 **SEC. 304. COOPERATIVE AGREEMENT WITH THE WILLIAM**  
17 **O. DOUGLAS OUTDOOR CLASSROOM.**

18 (a) GENERAL AUTHORITY.—The Secretary of the In-  
19 terior, acting through the Director of the National Park  
20 Service, is authorized to enter into cooperative agree-  
21 ments, as specified in subsection (b), relating to Santa  
22 Monica Mountains National Recreation Area (hereafter in  
23 this Act referred to as the “recreation area”) in accord-  
24 ance with this section.

1 (b) COOPERATIVE AGREEMENTS.—The cooperative  
2 agreements referred to in subsection (a) are as follows:

3 (1) A cooperative agreement with appropriate  
4 organizations or groups in order to promote edu-  
5 cation concerning the natural and cultural resources  
6 of the recreation area and lands adjacent thereto.  
7 Any agreement entered into pursuant to this para-  
8 graph—

9 (A) may provide for Federal matching  
10 grants of not more than 50 percent of the total  
11 cost of providing a program of such education;

12 (B) shall provide for visits by students or  
13 other beneficiaries to federally owned lands  
14 within the recreation area;

15 (C) shall limit the responsibility of the Sec-  
16 retary to providing interpretation services con-  
17 cerning the natural and cultural resources of  
18 the recreation area; and

19 (D) shall provide that the non-Federal  
20 party shall be responsible for any cost of carry-  
21 ing out the agreement other than the cost of  
22 providing interpretation services under subpara-  
23 graph (C).

24 (2) A cooperative agreement under which—

1 (A) the Secretary agrees to maintain the  
2 facilities at 2600 Franklin Canyon Drive in  
3 Beverly Hills, California, for a period of 8 fiscal  
4 years beginning with the first fiscal year for  
5 which funds are appropriated pursuant to this  
6 section, and to provide funding for programs of  
7 the William O. Douglas Outdoor Classroom or  
8 its successors in interest that utilize those fa-  
9 cilities during such period; and in return

10 (B) the William O. Douglas Outdoor Class-  
11 room, for itself and any successors in interest  
12 with respect to such facilities, agrees that at  
13 the end of the term of such agreement all right,  
14 title, and interest in and to such facilities will  
15 be donated to the United States for addition to  
16 and operation as a part of the recreation area.

17 (c) EXPENDITURE OF FUNDS.—Federal funds may  
18 be expended on non-Federal property located within the  
19 recreation area pursuant to the cooperative agreement de-  
20 scribed in subsection (b)(2).

21 (d) LIMITATIONS.—(1) The Secretary may not enter  
22 into the cooperative agreement described in subsection  
23 (b)(2) unless and until the Secretary determines that ac-  
24 quisition of the facilities described in such subsection  
25 would further the purposes of the recreation area.

1       (2) This section shall not be construed as authorizing  
2 an agreement by the Secretary for reimbursement of ex-  
3 penses incurred by the William O. Douglas Outdoor Class-  
4 room or any successor in interest that are not directly re-  
5 lated to the use of such facilities for environmental edu-  
6 cation and interpretation of the resources and values of  
7 the recreation area and associated lands and resources.

8       (e) AUTHORIZATION OF APPROPRIATIONS.—There is  
9 authorized to be appropriated for the 8-year period begin-  
10 ning October 1, 1993, not to exceed \$2,000,000 to carry  
11 out this section.

12 **SEC. 305. ABRAHAM LINCOLN PRESIDENTIAL CENTER.**

13       The Act entitled “An Act to authorize the Secretary  
14 of the Interior to establish the Lincoln Home National  
15 Historic Site in the State of Illinois, and for other pur-  
16 poses”, approved August 18, 1971 (85 Stat. 347), is  
17 amended by adding at the end the following new section:

18 **“SEC. 4. ABRAHAM LINCOLN PRESIDENTIAL CENTER.**

19       “(a) ESTABLISHMENT.—In order to provide for the  
20 education, inspiration and benefit of the American people,  
21 and to further the interpretation of the life and contribu-  
22 tions of Abraham Lincoln and his times, the Secretary of  
23 the Interior is authorized to establish at or near the Lin-  
24 coln Home National Historic Site an interpretive center  
25 which shall be known as the Abraham Lincoln Presidential

1 Center (hereafter in this section referred to as the ‘cen-  
2 ter’). The center shall be added to and administered as  
3 part of the Lincoln Home National Historic Site. Upon  
4 establishment of the center, the boundary of the Lincoln  
5 Home National Historic Site is hereby modified to include  
6 the center.

7 “(b) ACQUISITION OF LAND.—For the purposes of  
8 this section, the Secretary may acquire land or interests  
9 in land near the Lincoln Home National Historic Site by  
10 donation, purchase with donated or appropriated funds,  
11 or exchange. Lands or interests therein owned by the  
12 State of Illinois or any political subdivision thereof may  
13 be acquired only by donation.

14 “(c) CONSTRUCTION, OPERATION, AND MAINTENANCE OF FACILITIES.—In carrying out this section, the  
15 Secretary is authorized to construct, operate, and main-  
16 tain a facility, including an exhibit area, in order to pre-  
17 serve and make available materials related to the life of  
18 Abraham Lincoln and to provide interpretive and edu-  
19 cational services which communicate the meaning of the  
20 life of Abraham Lincoln.

22 “(d) COOPERATIVE AGREEMENTS.—In carrying out  
23 this section, the Secretary may enter into cooperative  
24 agreements with (1) appropriate Federal agencies and the  
25 State of Illinois, or any political subdivision thereof, for

1 the interpretation of resources at the center, and (2) with  
2 the owners of documents and artifacts of historical or cul-  
3 tural significance as determined by the Secretary.

4 “(e) DOCUMENTS AND ARTIFACTS.—In carrying out  
5 this section, the Secretary may acquire by purchase with  
6 donated funds, exchange, loan, or donation documents and  
7 artifacts related to the purposes of the center for display  
8 at the center.

9 “(f) AUTHORIZATION OF APPROPRIATIONS.—In addi-  
10 tion to amounts authorized to be appropriated by section  
11 3, there is authorized to be appropriated not more than  
12 \$18,000,000 to carry out this section.”.

13 **SEC. 306. COLONIAL NATIONAL HISTORICAL PARK**

14 (a) TRANSFER AND RIGHTS-OF-WAY.—The Sec-  
15 retary of the Interior (hereinafter in this Act referred to  
16 as the “Secretary”) is authorized to transfer, without re-  
17 imbursement, to York County, Virginia, that portion of  
18 the existing sewage disposal system, including related im-  
19 provements and structures, owned by the United States  
20 and located within the Colonial National Historical Park,  
21 together with such rights-of-way as are determined by the  
22 Secretary to be necessary to maintain and operate such  
23 system.

24 (b) REPAIR AND REHABILITATION OF SYSTEM.—The  
25 Secretary is authorized to enter into a cooperative agree-

1 ment with York County, Virginia, under which the Sec-  
2 retary will pay a portion, not to exceed \$110,000, of the  
3 costs of repair and rehabilitation of the sewage disposal  
4 system referred to in subsection (a).

5 (c) FEES AND CHARGES.—In consideration for the  
6 rights-of-way granted under subsection (a), and in rec-  
7 ognition of the National Park Service’s contribution au-  
8 thorized under subsection (b), the cooperative agreement  
9 under subsection (b) shall provide for a reduction in, or  
10 the elimination of, the amounts charged to the National  
11 Park Service for its sewage disposal. The cooperative  
12 agreement shall also provide for minimizing the impact of  
13 the sewage disposal system on the park and its resources.  
14 Such system may not be enlarged or substantially altered  
15 without National Park Service concurrence.

16 (d) EXPANSION.—Notwithstanding the provisions of  
17 the Act of June 28, 1938 (52 Stat. 1208; 16 U.S.C. 81b  
18 and following) limiting the average width of the Colonial  
19 Parkway, the Secretary is authorized to include within the  
20 Colonial National Historical Park, and to acquire by pur-  
21 chase, donation, or exchange, lands and interests in lands  
22 (with or without improvements) within the areas depicted  
23 on the map dated August 1993 and numbered 333/  
24 80031A, entitled “Page Landing Addition to Colonial Na-  
25 tional Historical Park”. Such map shall be on file and

1 available for inspection in the offices of the National Park  
2 Service at Colonial National Historical Park and in Wash-  
3 ington, D.C.

4 (e) AUTHORIZATION OF APPROPRIATIONS.—There  
5 are authorized to be appropriated such sums as may be  
6 necessary to carry out this section.

7 **SEC. 307. CHANNEL ISLANDS NATIONAL PARK.**

8 (a) DESIGNATION.—The visitors center at the Chan-  
9 nel Islands National Park, California, is designated as the  
10 “Robert J. Lagomarsino Visitors Center”.

11 (b) LEGAL REFERENCES.—Any reference in any law,  
12 regulation, document, record, map, or other paper of the  
13 United States to the visitors center referred to in sub-  
14 section (a) is deemed to be a reference to the “Robert J.  
15 Lagomarsino Visitors Center”.
