## AN ACT

To authorize the leasing of naval vessels to certain foreign countries.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. AUTHORITY TO LEASE NAVAL VESSELS TO CER-**  
4 **TAIN FOREIGN COUNTRIES.**

5 The Secretary of the Navy is authorized to lease to  
6 the following foreign governments the following naval  
7 vessels:

1           (1) BRAZIL.—To the Government of Brazil, the  
2           “KNOX” class frigates HEPBURN (FF 1055),  
3           PATTERSON (FF 1061), FRANCIS HAMMOND  
4           (FF 1067), DOWNES (FF 1070), BLAKELY (FF  
5           1072), and PAUL (FF 1080).

6           (2) EGYPT.—To the Government of Egypt, the  
7           “KNOX” class frigates JESSE L. BROWN (FFT  
8           1089) and MOINESTER (FFT 1097).

9           (3) MOROCCO.—To the Government of Mo-  
10          rocco, the “KNOX” class frigate VALDEZ (FF  
11          1096).

12          (4) OMAN.—To the Government of Oman, the  
13          “KNOX” class frigate MILLER (FF 1091).

14          (5) SPAIN.—To the Government of Spain, the  
15          “KNOX” class frigates AYLWIN (FF 1081) and  
16          PHARRIS (FF 1094).

17          (6) TAIWAN.—To the Coordination Council for  
18          North American Affairs (which is the Taiwan instru-  
19          mentality designated pursuant to section 10(a) of  
20          the Taiwan Relations Act), the “KNOX” class frig-  
21          ates JOSEPH HEWES (FFT 1078), COOK (FF  
22          1083), and BARBEY (FF 1088).

23          (7) THAILAND.—To the Government of Thai-  
24          land, the “KNOX” class frigates MARVIN  
25          SHIELDS (FF 1066), HAROLD E. HOLT (FF

1 1074), OUELLET (FF 1077), and TRUETT (FFT  
2 1095).

3 (8) TURKEY.—To the Government of Turkey,  
4 the “KNOX” class frigates BOWEN (FFT 1079),  
5 McCANDLESS (FFT 1084), DONALD B. BEARY  
6 (FFT 1085), and AINSWORTH (FFT 1090).

7 (9) VENEZUELA.—To the Government of Ven-  
8 ezuela, the “KNOX” class frigates ROARK (FF  
9 1053) and GRAY (FF 1054).

10 **SEC. 2. APPLICABLE LAW.**

11 The leases authorized by section 1 shall be in accord-  
12 ance with chapter 6 of the Arms Export Control Act (22  
13 U.S.C. 2796 and following), except that section 62 of that  
14 Act (22 U.S.C. 2796a; relating to reports to Congress)  
15 shall apply only to renewal of the leases.

16 **SEC. 3. COSTS OF LEASES.**

17 Any expense of the United States in connection with  
18 a lease authorized by section 1 shall be charged to the  
19 recipient.

20 **SEC. 4. EXPIRATION OF AUTHORITY.**

21 The authority granted by section 1 shall expire at the  
22 end of the 2-year period beginning on the date of the en-

- 1 actment of this Act, except that leases entered into under
- 2 that authority during that period may be renewed.
