## A BILL

To amend chapter 84 of title 5, United States Code, to provide that annuities for Members of Congress be computed under the same formula as applies to Federal employees generally, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*

3        **SECTION 1. COMPUTATION OF ANNUITY.**

4        (a) IN GENERAL.—Section 8415 of title 5, United  
5        States Code, is amended—

6                (1) in subsection (a) by inserting “or Member”  
7        after “employee”; and

8                (2) by repealing subsection (b).

1           (b)           TECHNICAL           AMENDMENT.—Section  
2 8468(b)(1)(A) of title 5, United States Code, is amended  
3 by striking “(a)” and inserting “(a) and (c)”.

4 **SEC. 2. CONTRIBUTIONS.**

5           (a) DEDUCTIONS FROM PAY.—Section 8422(a)(2) of  
6 title 5, United States Code, is amended—

7                   (1) in subparagraph (A) by inserting “or Mem-  
8 ber” after “employee”); and

9                   (2) in subparagraph (B) by striking “Mem-  
10 ber,”.

11           (b)           GOVERNMENT           CONTRIBUTIONS.—Section  
12 8423(a)(1) of title 5, United States Code, is amended—

13                   (1) in subparagraph (A)(i) by striking “sub-  
14 paragraph (B)),” and inserting “subparagraph (B))  
15 and Members,”;

16                   (2) in subparagraph (A)(ii) by inserting “and  
17 Members” before “(under”;

18                   (3) in subparagraph (B)(i) by striking “Mem-  
19 bers,”; and

20                   (4) in subparagraph (B)(ii) by striking “and  
21 Members”.

22 **SEC. 3. EFFECTIVE DATE; SAVINGS PROVISION.**

23           (a) EFFECTIVE DATE.—This Act shall take effect as  
24 of the first day of the first applicable pay period beginning

1 after the end of the 12-month period beginning on the date  
2 of the enactment of this Act.

3 (b) SAVINGS PROVISION.—Any annuity or portion of  
4 an annuity computed based on service performed before  
5 the effective date of this Act shall be computed in accord-  
6 ance with applicable provisions of law, as in effect imme-  
7 diately before the effective date of this Act.
