**A BILL**

To provide for an investigation of the whereabouts of the United States citizens and others who have been missing from Cyprus since 1974.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. UNITED STATES CITIZENS AND OTHERS MISS-**  
2 **ING FROM CYPRUS.**

3 (a) INVESTIGATION.—As soon as is practicable, the  
4 President shall undertake, in cooperation with an appro-  
5 priate international organization or nongovernmental or-  
6 ganization, a thorough investigation of the whereabouts of  
7 the United States citizens and others who have been miss-  
8 ing from Cyprus since 1974. The investigation shall focus  
9 on the countries and community which were combatants  
10 in Cyprus in 1974, all of which currently receive United  
11 States foreign assistance.

12 (b) RESULTS OF THE INVESTIGATION.—The Presi-  
13 dent shall report the findings of this investigation to the  
14 family of each of the United States citizens and others  
15 who have been missing from Cyprus since 1974 and to  
16 the Congress. Such reports shall include the whereabouts  
17 of the missing.

18 (c) RETURNING THE MISSING.—The President, in  
19 cooperation with an appropriate international organization  
20 or nongovernmental organization, shall do everything pos-  
21 sible to return to their families, as soon as is practicable,  
22 the United States citizens and others who have been miss-  
23 ing from Cyprus since 1974, including returning the re-  
24 mains of those who are no longer alive.
