3 Section 639 of the Head Start Act (42 U.S.C. 9834)

4 is amended—

5 (1) in subsection (a)—

6 (A) by striking “and \$7,660,000,000” and
7 inserting “\$7,660,000,000”; and

8 (B) by inserting before the period the fol-
9 lowing: “, and such sums as may be necessary
10 for each of the fiscal years 1995 through
11 1998”;

12 (2) in subsection (b), by striking “1996” and
13 inserting “1998”; and

14 (3) in subsection (c)(2), by striking “1992,
15 1993, and 1994” and inserting “1992 through
16 1998”.

3 **SEC. 201. AUTHORIZATION OF APPROPRIATIONS.**

4 (a) GENERAL AUTHORIZATION.—Section 672(b) of
5 the Community Services Block Grant Act (42 U.S.C.
6 9901(b)) is amended—

7 (1) by striking “and \$500,000,000” and insert-
8 ing “\$500,000,000”; and

9 (2) by inserting before “to carry out the provi-
10 sions” the following: “, and such sums as may be
11 necessary for each of the fiscal years 1995 through
12 1998”.

13 (b) COMMUNITY FOOD AND NUTRITION PRO-
14 GRAMS.—Section 681A(d) of such Act (42 U.S.C.
15 9910a(d)) is amended—

16 (1) by striking “and \$25,000,000” and insert-
17 ing “\$25,000,000”; and

18 (2) by inserting before “to carry out this sec-
19 tion” the following: “, and such sums as may be nec-
20 essary for each of the fiscal years 1995 through
21 1998”.

9 and 1994” and inserting “1992 through 1998”; and

10 (2) in paragraph (2), by striking “1992
11 through 1994” and inserting “1992 through 1998”.

15 **SEC. 401. AUTHORIZATION OF APPROPRIATIONS.**

16 Section 2602 of the Low-Income Home Energy As-
17 sistance Act of 1981 (42 U.S.C. 8621) is amended—

18 (1) in subsection (b), by striking “1993, 1994,
19 and 1995” and inserting “1993 through 1998”; and

20 (2) in subsection (d), by striking “1993, 1994,
21 and 1995” and inserting “1993 through 1998”.

1 **TITLE V—COORDINATED SERV-**
2 **ICES FOR CHILDREN, YOUTH,**
3 **AND FAMILIES**

4 **SEC. 501. AUTHORIZATION OF APPROPRIATIONS.**

5 (a) IN GENERAL.—Section 934 of the Augustus F.
6 Hawkins Human Services Reauthorization Act of 1990
7 (42 U.S.C. 12340) is amended—

8 (1) in subsection (a)(1), by striking “for fiscal
9 years 1992, 1993, and 1994” and inserting “for
10 each of the fiscal years 1992 through 1998”; and

11 (2) in subsection (d), by striking “1992 through
12 1994” and inserting “1992 through 1998”.

13 (b) NATIONAL CLEARINGHOUSE.—Section 960 of
14 such Act (42 U.S.C. 12355) is amended—

15 (1) in subsection (a), by striking “1992 through
16 1994” and inserting “1992 through 1998”; and

17 (2) in subsection (b), by striking “1992 through
18 1994” and inserting “1992 through 1998”.
