A BILL

To reauthorize for three years the Commission on Civil Rights, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Civil Rights Commis-
5 sion Reauthorization Act of 1994”.

1 **SEC. 2. COMMISSION ON CIVIL RIGHTS.**

2 Section 5(a) of the United States Commission on
3 Civil Rights Act of 1983 (42 U.S.C. 1975c(a)) is amended
4 to read as follows:

5 “(a) INVESTIGATORY AND OTHER DUTIES.—The
6 Commission shall—

7 “(1) investigate allegations, in writing, under
8 oath or affirmation, relating to deprivations of civil
9 rights based on color, race, religion, sex, age, disabili-
10 ty, or national origin, or as a result of any pattern
11 or practice of fraud, or denial of the right to vote
12 and have votes counted; and

13 “(2) study, collect, make appraisals of, serve as
14 a national clearinghouse for information on, and
15 prepare public service announcements and advertis-
16 ing campaigns to discourage discrimination or the
17 denial of equal protection of the laws, including the
18 administration of justice, based on color, race, reli-
19 gion, sex, age, disability, or national origin.”.

20 **SEC. 3. REAUTHORIZATION.**

21 Section 7 of the United States Commission on Civil
22 Rights Act (42 U.S.C. 1975e) is amended to read as
23 follows:

24 **“SEC. 7. AUTHORIZATION OF APPROPRIATIONS.**

25 “There is authorized to be appropriated to carry out
26 this Act \$9,500,000 for fiscal year 1995.”.

1 **SEC. 4. TERMINATION.**

2 Section 8 of the United States Commission on Civil
3 Rights Act (42 U.S.C. 1973f) is amended by striking
4 “1994” and inserting “1997”.
