To amend the National Parks and Recreation Act of 1978 to establish the Friends of Kaloko-Honokohau, an advisory commission for the Kaloko-Honokohau National Historical Park, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Friends of Kaloko-
3 Honokohau Act of 1993”.

4 **SEC. 2. FRIENDS OF KALOKO-HONOKOHAU.**

5 Paragraph (7) of section 505(f) of the National
6 Parks and Recreation Act of 1978 (16 U.S.C. 396d(f)(7))
7 is amended to read as follows:

8 “(7) The Commission shall resume carrying out its
9 responsibilities under this Act not later than 180 days
10 after the date of enactment of the Friends of Kaloko-
11 Honokohau Act of 1993.”

12 **SECTION 1. SHORT TITLE.**

13 This Act may be cited as the “Na Hoa Pili Kaloko-
14 Honokohau Re-establishment Act of 1993”.

15 **SEC. 2. RE-ESTABLISHMENT OF ADVISORY COMMISSION.**

16 (a) Notwithstanding section 505(f)(7) of Public Law
17 95–625 (16 U.S.C. 396d(7)), the Na Hoa Pili O Kaloko-
18 Honokohau, the Advisory Commission for Kaloko-
19 Honokohau National Historical Park, is hereby re-estab-
20 lished in accordance with section 505(f), as amended by
21 subsection (b) of this section.

22 (b) Section 505(f)(7) of Public Law 95–625 (16 U.S.C.
23 396d(7)), is amended by striking “this Act” and inserting
24 in lieu thereof, “the Na Hoa Pili Kaloko-Honokohau Re-
25 establishment Act of 1993”.
