## A BILL

To amend title XVIII of the Social Security Act to provide annual screening mammography and waive deductibles and coinsurance for screening mammography under the medicare program.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Medicare Mammog-  
5 raphy Enhancement Act of 1996”.

1 **SEC. 2. EXPANDING SCREENING MAMMOGRAPHY UNDER**  
2 **THE MEDICARE PROGRAM.**

3 (a) PROVIDING ANNUAL SCREENING MAMMOGRAPHY  
4 FOR WOMEN OVER AGE 49.—Section 1834(c)(2)(A) of  
5 the Social Security Act (42 U.S.C. 1395m(c)(2)(A)) is  
6 amended—

7 (1) in clause (iv), by striking “but under 65  
8 years of age,”, and

9 (2) by striking clause (v).

10 (b) WAIVER OF DEDUCTIBLE.—

11 (1) IN GENERAL.—The first sentence of section  
12 1833(b) of such Act (42 U.S.C. 1395l(b)) is amend-  
13 ed—

14 (A) by striking “and (4)” and inserting  
15 “(4)”, and

16 (B) by striking the period at the end and  
17 inserting the following: “, and (5) such deduct-  
18 ible shall not apply with respect to screening  
19 mammography (as described in section  
20 1861(jj)).”.

21 (2) CONFORMING AMENDMENT.—Section  
22 1834(c)(1)(C) of such Act (42 U.S.C.  
23 1395m(c)(1)(C)) is amended by striking “, subject  
24 to the deductible established under section  
25 1833(b).”.

26 (c) WAIVER OF COINSURANCE.—

1           (1) IN GENERAL.—Section 1834(c)(1)(C) of  
2 such Act (42 U.S.C. 1395m(c)(1)(C)) is amended by  
3 striking “80 percent of”.

4           (2) WAIVER OF COINSURANCE IN OUTPATIENT  
5 HOSPITAL SETTINGS.—The third sentence of section  
6 1866(a)(2)(A) of such Act (42 U.S.C.  
7 1395cc(a)(2)(A)) is amended by inserting after  
8 “1861(s)(10)(A)” the following: “, with respect to  
9 screening mammography (as defined in section  
10 1861(jj)),”.

11          (d) EFFECTIVE DATE.—The amendments made by  
12 this section shall apply to screening mammography per-  
13 formed on or after January 1, 1997.
