Mr. SANDERS introduced the following bill; which was referred to the Committee on National Security

A BILL

To amend section 818 of the National Defense Authorization Act for Fiscal Year 1995 to repeal certain provisions and revise certain reporting requirements relating to payment of restructuring costs under defense contracts.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 (a) REPEAL.—Section 818 of the National Defense
4 Authorization Act for Fiscal Year 1995 (Public Law 103–
5 337; 108 Stat. 2821; 10 U.S.C. 2324 note) is amended—

6 (1) by striking out subsections (a), (b), (c), and
7 (d); and

1 (2) by redesignating subsections (e), (f), and
2 (g) as subsections (a), (b), and (c), respectively.

3 (b) AMENDMENTS RELATING TO REPORT BY SEC-
4 RETARY OF DEFENSE.—Subsection (a) of section 818 of
5 such Act (as redesignated by subsection (a)(2)) is amend-
6 ed—

7 (1) in the matter preceding paragraph (1), by
8 striking out “1995, 1996, and 1997” and inserting
9 in lieu thereof “1995 and 1996”; and

10 (2) in paragraph (3), by inserting at the end
11 the following new subparagraph:

12 “(F) Actual employment data within de-
13 fense contractors immediately before public an-
14 nouncement of plans for each business combina-
15 tion since July 21, 1993, and layoffs subse-
16 quent to approval of each such business com-
17 bination, along with an estimate of the costs to
18 the United States resulting from the layoffs.”.

19 (c) AMENDMENTS RELATING REPORT BY COMP-
20 TROLLER GENERAL.—Subsection (c) of section 818 of
21 such Act (as redesignated by subsection (a)(2)) is amend-
22 ed—

23 (1) in paragraph (2)—

1 (A) by striking out “periodically” and in-
2 serting in lieu thereof “quarterly every fiscal
3 year”; and

4 (B) by striking out the period at the end
5 and inserting in lieu thereof the following: “, in-
6 cluding the amount of appropriated funds obli-
7 gated for each business combination.”; and

8 (2) in paragraph (3), by striking out “1997”
9 and inserting in lieu thereof “1996”.
