1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. BOUNDARY ADJUSTMENT, DEVILS BACKBONE**
 4 **WILDERNESS, MARK TWAIN NATIONAL FOR-**
 5 **EST, MISSOURI.**

6 Using the authority provided in section 202 of Public
 7 Law 96–560 (94 Stat. 3274) regarding the correction of
 8 clerical errors in the maps and legal descriptions of the
 9 Devils Backbone Wilderness established by section 201(d)
 10 of such Act (16 U.S.C. 1132 note), the Secretary of Agri-
 11 culture shall adjust the exterior boundary of the Devils
 12 Backbone Wilderness in the Mark Twain National Forest,
 13 Missouri, to exclude a parcel of real property that consists
 14 of approximately a quarter of an acre in Douglas County,
 15 Missouri, contains a garage, well, mailbox, driveway, and
 16 other improvements, and was inadvertently removed from
 17 administration as National Forest System land and in-
 18 cluded within the wilderness area.

19 **SECTION 1. BOUNDARY ADJUSTMENT, DEVILS BACKBONE**
 20 **WILDERNESS, MARK TWAIN NATIONAL FOR-**
 21 **EST, MISSOURI.**

22 *The boundary of the Devils Backbone Wilderness estab-*
 23 *lished by section 201(d) of Public Law 96–560 (16 U.S.C.*
 24 *1132 note) in the Mark Twain National Forest, Missouri,*

1 *is hereby modified to exclude from the area encompassed*
2 *by the Devils Backbone Wilderness a parcel of real property*
3 *consisting of approximately two acres in Ozark County,*
4 *Missouri, and containing a garage, well, mailbox, drive-*
5 *way, and other improvements, as depicted on a map enti-*
6 *led “Devils Backbone Wilderness Boundary Modification”,*
7 *dated June 1996. The map shall be retained with other For-*
8 *est Service maps and legal descriptions regarding the Devils*
9 *Backbone Wilderness and shall be made available for public*
10 *inspection as provided in section 202 of Public Law 96-*
11 *560 (94 Stat. 3274).*
