A BILL

To direct the Secretary of the Interior to convey the Marion National Fish Hatchery to the State of Alabama.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “~~Marion National Fish~~
5 ~~Hatchery Conveyance Act~~”.

1 **SEC. 2. CONVEYANCE OF MARION NATIONAL FISH HATCH-**
2 **ERY TO THE STATE OF ALABAMA.**

3 (a) **CONVEYANCE REQUIREMENT.**—Within 180 days
4 after the date of the enactment of this Act, the Secretary
5 of the Interior shall convey to the State of Alabama with-
6 out reimbursement all right, title, and interest of the Unit-
7 ed States in and to the property described in subsection
8 (b) for use by the Game and Fish Division of the Alabama
9 Department of Conservation and Natural Resources as
10 part of the State of Alabama fish culture program.

11 (b) **PROPERTY DESCRIBED.**—The property referred
12 to in subsection (a) consists of—

13 (1) that portion of the Marion National Fish
14 Hatchery leased to the Alabama Game and Fish Di-
15 vision, located on State Highway 175 seven miles
16 northeast of Marion, Alabama, as described in
17 Amendment No. 2 to the Cooperative Agreement
18 dated June 6, 1974, between the United States Fish
19 and Wildlife Service and the State of Alabama, De-
20 partment of Conservation and Natural Resources,
21 Game and Fish Division, comprised of approximately
22 300 acres (more or less);

23 (2) all improvements and related personal prop-
24 erty under the control of the Secretary that is lo-
25 cated on that property, including buildings, struc-

1 tures, equipment, and all easements and leases relat-
2 ing to that property; and

3 ~~(3) all water rights and timber rights relating~~
4 ~~to that property.~~

5 ~~(c) USE AND REVERSIONARY INTEREST.—The prop-~~
6 ~~erty conveyed to the State of Alabama under this section~~
7 ~~shall be used by the State for purposes of fishery resources~~
8 ~~management and fisheries-related activities. If it is used~~
9 ~~for any other purpose detrimental to those purposes and~~
10 ~~activities, all right, title, and interest in and to all property~~
11 ~~conveyed under this section shall revert to the United~~
12 ~~States. The State of Alabama shall ensure that property~~
13 ~~reverting to the United States under this subsection is in~~
14 ~~substantially the same or better condition as at the time~~
15 ~~of transfer to the State, except for any timber interest or~~
16 ~~mineral interest in the property that is sold or leased by~~
17 ~~the State.~~

18 **SECTION 1. SHORT TITLE.**

19 *This Act may be cited as the “Marion National Fish*
20 *Hatchery Conveyance Act”.*

21 **SEC. 2. CONVEYANCE OF MARION NATIONAL FISH HATCH-**
22 **ERY TO THE STATE OF ALABAMA.**

23 *(a) CONVEYANCE REQUIREMENT.—Within 180 days*
24 *after the date of the enactment of this Act, the Secretary*
25 *of the Interior shall convey to the State of Alabama without*

1 reimbursement all right, title, and interest of the United
2 States in and to the property described in subsection (b)
3 for use by the Game and Fish Division of the Alabama De-
4 partment of Conservation and Natural Resources as part
5 of the State of Alabama fish culture program.

6 (b) *PROPERTY DESCRIBED.*—The property referred to
7 in subsection (a) consists of—

8 (1) that portion of the Marion National Fish
9 Hatchery leased to the Alabama Game and Fish Divi-
10 sion, located on State Highway 175 seven miles
11 northeast of Marion, Alabama, as described in
12 Amendment No. 2 to the Cooperative Agreement dated
13 June 6, 1974, between the United States Fish and
14 Wildlife Service and the State of Alabama, Depart-
15 ment of Conservation and Natural Resources, Game
16 and Fish Division, comprised of approximately 300
17 acres (more or less);

18 (2) all improvements and related personal prop-
19 erty under the control of the Secretary that is located
20 on that property, including buildings, structures,
21 equipment, and all easements and leases relating to
22 that property; and

23 (3) all water rights relating to that property.

24 (c) *REVERSIONARY INTEREST.*—If any of the property
25 conveyed to the State of Alabama under this section is used

1 *for any purpose other than the use authorized under sub-*
2 *section (a), all right, title, and interest in and to all prop-*
3 *erty conveyed under this section shall revert to the United*
4 *States. The State of Alabama shall ensure that all property*
5 *reverting to the United States under this subsection is in*
6 *substantially the same or better condition as at the time*
7 *of transfer to the State.*
