To designate the Federal building and U.S. Courthouse located at 125 Market Street in Youngstown, Ohio, as the “Thomas D. Lambros Federal Building and U.S. Courthouse”.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. DESIGNATION.**

2 The Federal building located at 125 Market Street  
3 in Youngstown, Ohio, shall be known and designated as  
4 the “Thomas D. Lambros Federal Building”.

5 **SEC. 2. REFERENCES.**

6 Any reference in a law, map, regulation, document,  
7 paper, or other record of the United States to the Federal  
8 building referred to in section 1 shall be deemed to be  
9 a reference to the “Thomas D. Lambros Federal Build-  
10 ing”.

11 **SECTION 1. DESIGNATION.**

12 *The Federal building and United States courthouse lo-*  
13 *cated at 125 Market Street in Youngstown, Ohio, shall be*  
14 *known and designated as the “Thomas D. Lambros Federal*  
15 *Building and United States Courthouse”.*

16 **SEC. 2. REFERENCES.**

17 *Any reference in a law, map, regulation, document,*  
18 *paper, or other record of the United States to the Federal*  
19 *building and United States courthouse referred to in section*  
20 *1 shall be deemed to be a reference to the “Thomas D.*  
21 *Lambros Federal Building and United States Courthouse”.*

Amend the title so as to read: “A bill to designate the Federal building and United States courthouse located at 125 Market Street in Youngstown, Ohio, as the ‘Thomas D. Lambros Federal Building and United States Courthouse’.”.
