Mr. SOLOMON, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

---

## RESOLUTION

Providing for consideration of a joint resolution and a resolution relating to the People's Republic of China.

1       *Resolved*, That upon the adoption of this resolution  
2 it shall be in order to consider in the House the joint reso-  
3 lution (H.J. Res. 182) disapproving the extension of non-  
4 discriminatory treatment (most-favored-nation treatment)  
5 to the products of the People's Republic of China. All  
6 points of order against the joint resolution and against  
7 its consideration are waived. The joint resolution shall be  
8 debatable for two hours equally divided and controlled by

1 the chairman of the Committee on Ways and Means (in  
2 opposition to the joint resolution) and a Member in sup-  
3 port of the joint resolution. Pursuant to sections 152 and  
4 153 of the Trade Act of 1974, the previous question shall  
5 be considered as ordered on the joint resolution to final  
6 passage without intervening motion. The provisions of sec-  
7 tions 152 and 153 of the Trade Act of 1974 shall not  
8 apply to any other joint resolution disapproving the exten-  
9 sion of most-favored-nation treatment to the People's Re-  
10 public of China for the remainder of the One Hundred  
11 Fourth Congress.

12       SEC. 2. After disposition of House Joint Resolution  
13 182 pursuant to the first section of this resolution, it shall  
14 be in order to consider in the House the resolution (H.  
15 Res. 461) regarding human rights abuses, nuclear and  
16 chemical weapons proliferation, illegal weapons trading,  
17 military intimidation of Taiwan, and trade violations by  
18 the People's Republic of China and the People's Libera-  
19 tion Army, and directing the committees of jurisdiction to  
20 commence hearings and report appropriate legislation.  
21 The resolution shall be debatable for one hour equally di-  
22 vided and controlled by Representative Cox of California  
23 or his designee and a Member opposed to the resolution.  
24 The previous question shall be considered as ordered on

- 1 the resolution to final adoption without intervening mo-
- 2 tion.
