Mr. MOYNIHAN introduced the following bill; which was read twice and referred to the Committee on Energy and Natural Resources

## A BILL

To improve the administration of the Women's Rights National Historical Park in the State of New York, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. COMPOSITION.**

4       The second sentence of section 1601(c) of Public Law  
5       96-607 (16 U.S.C. 410*l*) is amended—

6               (1) by striking “initially”;

7               (2) by striking paragraph (7);

8               (3) by redesignating paragraphs (8) and (9) as  
9       paragraphs (7) and (8), respectively;

1 (4) in paragraph (7) (as redesignated), by strik-  
2 ing “and” at the end;

3 (5) in paragraph (8) (as redesignated), by strik-  
4 ing the period at the end and inserting a semicolon;  
5 and

6 (6) by adding at the end the following:

7 “(9) not to exceed 1 acre, plus improvements,  
8 as determined by the Secretary, in Seneca Falls for  
9 development of a maintenance facility;

10 “(10) dwelling, 1 Seneca Street, Seneca Falls;

11 “(11) dwelling, 10 Seneca Street, Seneca Falls;

12 “(12) parcels adjacent to Wesleyan Chapel  
13 Block, including Clinton Street, Fall Street, and  
14 Mynderse Street, Seneca Falls; and

15 “(13) dwelling, 12 East Williams Street, Water-  
16 loo.”.

17 **SEC. 2. MISCELLANEOUS AMENDMENTS.**

18 Section 1601 of Public Law 96-607 (16 U.S.C.  
19 410*l*) is amended—

20 (1) in subsection (h)(5), by striking “ten years”  
21 and inserting “25 years”; and

22 (2) in subsection (i)—

23 (A) by inserting “(1)” after “(i)”;

24 (B) by striking “\$700,000” and inserting  
25 “\$1,500,000”;

1 (C) by striking “\$500,000” and inserting  
2 and “\$15,000,000”; and

3 (D) by adding at the end the following:

4 “(2) In addition to the sums appropriated before the  
5 date of enactment of this paragraph for land acquisition  
6 and development to carry out this section, there are au-  
7 thorized to be appropriated for fiscal years beginning after  
8 September 30, 1994, \$2,000,000.”.
