Mr. BREAUX introduced the following bill; which was read twice and referred to the Committee on Finance

A BILL

To amend title II of the Social Security Act to repeal the rule providing for termination of disabled adult child's benefits upon marriage.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REPEAL OF RULE PROVIDING FOR TERMI-**
4 **NATION OF DISABLED ADULT CHILD'S BENE-**
5 **FITS UPON MARRIAGE.**

6 (a) IN GENERAL.—Section 202(d) of the Social Secu-
7 rity Act (42 U.S.C. 402(d)) is amended—

8 (1) in paragraph (1)(D), by striking “or mar-
9 rries,”;

10 (2) by striking paragraph (5); and

1 (3) in paragraph (6)—

2 (A) by inserting “(other than by reason of
3 death)” after “terminated”,

4 (B) by striking “(provided no event speci-
5 fied in paragraph (1)(D) has occurred)”, and

6 (C) by striking “the first month in which
7 an event specified in paragraph (1)(D) occurs”
8 in subparagraph (C) and inserting “the month
9 in which the child’s death occurs”.

10 (b) CONFORMING AMENDMENTS.—

11 (1) Section 202(d) of such Act (as amended by
12 subsection (a)) is further amended by redesignating
13 paragraphs (6), (7), (8), and (9) as paragraphs (5),
14 (6), (7), and (8), respectively.

15 (2) Section 202(s)(2) of such Act (42 U.S.C.
16 402(s)(2)) is amended by striking “So much of sub-
17 sections (b)(3), (c)(4), (d)(5), (g)(3), and (h)(4) of
18 this section as precedes the semicolon,” and insert-
19 ing “Subsections (b)(3), (c)(4), (g)(3), and (h)(4) of
20 this section”.

21 (3) Section 223(e) of such Act (42 U.S.C.
22 423(e)) is amended by striking “(d)(6)(A)(ii),
23 (d)(6)(B),” and inserting “(d)(5)(A)(ii), (d)(5)(B)”.

1 (c) EFFECTIVE DATE.—The amendments made by
2 this section shall apply with respect to marriages occur-
3 ring on or after May 1, 1995.
