## A BILL

To revise the boundaries of the Hagerman Fossil Beds National Monument and the Craters of the Moon National Monument, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Idaho National Monu-  
5       ment Boundary Revision Act of 1995”.

6       **SEC. 2. HAGERMAN FOSSIL BEDS NATIONAL MONUMENT.**

7       Section 302(a) of the Arizona-Idaho Conservation  
8       Act of 1988 (102 Stat. 4576) is amended—

9               (1) by striking “(a) The Secretary” and insert-  
10       ing “(a)(1) The Secretary”; and

1           (2) by adding at the end the following new  
2 paragraph:

3           “(2) Notwithstanding paragraph (1), the Secretary is  
4 authorized to acquire from willing sellers, by donation, ex-  
5 change, or purchase with donated or appropriated funds,  
6 not more than 65 acres outside the boundary depicted on  
7 the map referred to in section 301(b) for the purpose of  
8 developing the acquired lands and operating research, in-  
9 formation, interpretive, and administrative facilities.  
10 Lands acquired and facilities developed under this para-  
11 graph shall be administered by the Secretary as part of  
12 the monument. The boundary of the monument shall be  
13 modified to include the lands added under this paragraph  
14 as a noncontiguous parcel.”.

15 **SEC. 3. CRATERS OF THE MOON NATIONAL MONUMENT.**

16           (a) IN GENERAL.—The boundary of Craters of the  
17 Moon National Monument, Idaho, is revised to add ap-  
18 proximately 210 acres and to delete approximately 315  
19 acres as generally depicted on the map entitled “Craters  
20 of the Moon National Monument, Idaho, Proposed 1987  
21 Boundary Adjustment”, numbered 131–80,008, and dated  
22 October 1987, which shall be on file and available for pub-  
23 lic inspection in the Office of the National Park Service  
24 of the Department of the Interior.

1       (b) ACQUISITION OF LAND.—The Secretary of the  
2 Interior is authorized to acquire from willing sellers, by  
3 donation, exchange, or purchase with donated or appro-  
4 priated funds, land and interests in land within the bound-  
5 ary described in subsection (a).

6       (c) LAND OUTSIDE BOUNDARY.—Land and interests  
7 in land that were inside the boundary of Craters of the  
8 Moon National Monument prior to the boundary revisions  
9 made by this section and that are not inside the boundary  
10 after the revisions, shall be administered by the Secretary  
11 of the Interior through the Bureau of Land Management  
12 in accordance with the Federal Land Policy and Manage-  
13 ment Act of 1976 (43 U.S.C. 1701 et seq.).

14       (d) AUTHORIZATION OF APPROPRIATIONS.—There  
15 are authorized to be appropriated such sums as are nec-  
16 essary to carry out this section.
