which was referred to the Committee on Banking and Financial Services

A BILL

To require the Secretary of the Treasury to redesign the \$1 bill so as to incorporate the preamble to the Constitution of the United States, a list describing the Articles of the Constitution, and a list describing the Articles of Amendment, on the reverse side of such currency.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Liberty Dollar Bill
5 Act”.

6 **SEC. 2. FINDINGS.**

7 The Congress finds as follows:

1 (1) Many Americans are unaware of the provi-
2 sions of the Constitution of the United States, one
3 of the most remarkable and important documents in
4 world history.

5 (2) An abbreviated version of this important
6 document, consisting of the preamble, a list of the
7 Articles, and a list of the Articles of Amendment,
8 could easily be placed on the reverse side of the \$1
9 Federal reserve note.

10 (3) The placement of an abbreviated version of
11 the Constitution on the \$1 Federal reserve note, a
12 unit of currency used daily by virtually all Ameri-
13 cans, would serve to remind people of the historical
14 importance of the Constitution and its impact on
15 their lives today.

16 (4) Americans would be reminded by the pre-
17 amble of the blessings of liberty; by the Articles, of
18 the framework of the Government; and by the Arti-
19 cles of Amendment, of the historical changes to the
20 document that forms the very core of the American
21 experience.


22 **SEC. 3. REDESIGN OF REVERSE SIDE OF THE \$1 BILL.**

23 (a) IN GENERAL.—Section 5114 of title 31, United
24 States Code, is amended by adding at the end the follow-
25 ing new subsection:

1 “(d) LIBERTY DOLLAR BILLS.—

2 “(1) IN GENERAL.—In addition to the require-
3 ments of subsection (b) (relating to the inclusion of
4 the inscription ‘In God We Trust’ on all United
5 States currency) and the 8th undesignated para-
6 graph of section 16 of the Federal Reserve Act, the
7 design of the reverse side of \$1 Federal reserve
8 notes shall incorporate the preamble to the Constitu-
9 tion of the United States, a list describing the Arti-
10 cles of the Constitution, and a list describing the Ar-
11 ticles of Amendment.

12 “(2) DESIGN.—Subject to paragraph (3), the
13 preamble to the Constitution of the United States
14 and the list describing the Articles of the Constitu-
15 tion shall appear on the reverse side of the \$1 Fed-
16 eral reserve note in the following format:



17 “(3) AUTHORITY OF SECRETARY.—The require-
18 ments of this subsection shall not be construed as—

19 “(A) prohibiting the inclusion of any other
20 inscriptions or material on the reverse side of

1 the \$1 Federal reserve note which the Secretary
2 may determine to be necessary or appropriate;
3 or

4 “(B) limiting any other authority of the
5 Secretary with regard to the design of the \$1
6 Federal reserve note, including the adoption of
7 any design features to deter the counterfeiting
8 of United States currency.”.

9 (b) DATE OF APPLICATION.—The amendment made
10 by subsection (a) shall apply to \$1 Federal reserve notes
11 which are first placed into circulation after December 31,
12 1999.
