**AN ACT**

To provide for the conveyance of certain land in the Six Rivers National Forest in the State of California for the benefit of the Hoopa Valley Tribe.

1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*

3        **SECTION 1. SHORT TITLE.**

4        This Act may be cited as the “Hoopa Valley Reserva-  
5        tion South Boundary Adjustment Act”.

1 **SEC. 2. TRANSFER OF LANDS WITHIN SIX RIVERS NA-**  
2 **TIONAL FOREST FOR HOOPA VALLEY TRIBE.**

3 (a) TRANSFER.—All right, title, and interest in and  
4 to the lands described in subsection (b) shall hereafter be  
5 administered by the Secretary of the Interior and be held  
6 in trust by the United States for the Hoopa Valley Tribe.  
7 The lands are hereby declared part of the Hoopa Valley  
8 Reservation. Upon the inclusion of such lands in the  
9 Hoopa Valley Reservation, Forest Service system roads  
10 numbered 8N03 and 7N51 and the Trinity River access  
11 road which is a spur off road numbered 7N51, shall be  
12 Indian reservation roads, as defined in section 101(a) of  
13 title 23 of the United States Code.

14 (b) LANDS DESCRIBED.—The lands referred to in  
15 subsection (a) are those portions of Townships 7 North  
16 and 8 North, Ranges 5 East and 6 East, Humboldt Merid-  
17 ian, California, within a boundary beginning at a point  
18 on the current south boundary of the Hoopa Valley Indian  
19 Reservation, marked and identified as “Post H.V.R. No.  
20 8” on the Plat of the Hoopa Valley Indian Reservation  
21 prepared from a field survey conducted by C.T. Bissel, Au-  
22 gustus T. Smith, and C.A. Robinson, Deputy Surveyors,  
23 approved by the Surveyor General, H. Pratt, March 18,  
24 1892, and extending from said point on a bearing of north  
25 72 degrees 30 minutes east, until intersecting with a line  
26 beginning at a point marked as “Post H.V.R. No. 3” on

1 such survey and extending on a bearing of south 15 de-  
2 grees 59 minutes east, comprising 2,641 acres more or  
3 less.

4 (c) BOUNDARY ADJUSTMENT.—The boundary of the  
5 Six Rivers National Forest in the State of California is  
6 hereby adjusted to exclude the lands to be held in trust  
7 for the benefit of the Hoopa Valley Tribe pursuant to this  
8 section.

9 (d) SURVEY.—The Secretary of the Interior, acting  
10 through the Bureau of Land Management, shall survey  
11 and monument that portion of the boundary of the Hoopa  
12 Valley Reservation established by the addition of the lands  
13 described in subsection (b).

14 (e) SETTLEMENT OF CLAIMS.—The transfer of lands  
15 to trust status under this section extinguishes the follow-  
16 ing claims by the Hoopa Valley Tribe:

17 (1) All claims on land now administered as part  
18 of the Six Rivers National Forest based on the alle-  
19 gation of error in establishing the boundaries of the  
20 Hoopa Valley Reservation, as those boundaries were  
21 configured before the date of the enactment of this  
22 Act.

23 (2) All claims of failure to pay just compensa-  
24 tion for a taking under the fifth amendment to the  
25 United States Constitution, if such claims are based

1 on activities, occurring before the date of the enact-  
2 ment of this Act, related to the lands transferred to  
3 trust status under this section.
