Mr. GOSS, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 437) to reauthorize the National Sea Grant College Program Act, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 1(b) of
3 rule XXIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 437) to reauthorize the National
6 Sea Grant College Program Act, and for other purposes.
7 The first reading of the bill shall be dispensed with. Gen-

1 eral debate shall be confined to the bill and shall not ex-
2 ceed one hour, with forty minutes equally divided and con-
3 trolled by the chairman and ranking minority member of
4 the Committee on Resources and twenty minutes equally
5 divided and controlled by the chairman and ranking mi-
6 nority member of the Committee on Science. After general
7 debate the bill shall be considered for amendment under
8 the five-minute rule. In lieu of the amendment rec-
9 ommended by the Committee on Science now printed in
10 the bill, it shall be in order to consider as an original bill
11 for the purpose of amendment under the five-minute rule
12 the amendment in the nature of a substitute printed in
13 the Congressional Record and numbered 1 pursuant to
14 clause 6 of rule XXIII. Each section of that amendment
15 shall be considered as read. At the conclusion of consider-
16 ation of the bill for amendment the Committee shall rise
17 and report the bill to the House with such amendments
18 as may have been adopted. Any Member may demand a
19 separate vote in the House on any amendment adopted
20 in the Committee of the Whole to the bill or to the amend-
21 ment in the nature of a substitute made in order as origi-
22 nal text. The previous question shall be considered as or-
23 dered on the bill and amendments thereto to final passage
24 without intervening motion except one motion to recommit
25 with or without instructions.
