A BILL

To amend the Public Health Service Act to revise and extend certain programs with respect to women's health research and prevention activities at the National Institutes of Health and the Centers for Disease Control and Prevention.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Women’s Health Re-
3 search and Prevention Amendments of 1998”.

4 **TITLE I—PROVISIONS RELATING**
5 **TO WOMEN’S HEALTH RE-**
6 **SEARCH AT THE NATIONAL**
7 **INSTITUTES OF HEALTH**

8 **SEC. 101. EXTENSION OF PROGRAM FOR RESEARCH AND**
9 **AUTHORIZATION OF NATIONAL PROGRAM OF**
10 **EDUCATION REGARDING THE DRUG DES.**

11 (a) IN GENERAL.—Section 403A(e) of the Public
12 Health Service Act (42 U.S.C. 283a(e)) is amended by
13 striking “1996” and inserting “2001”.

14 (b) NATIONAL PROGRAM FOR EDUCATION OF
15 HEALTH PROFESSIONALS AND PUBLIC.—From amounts
16 appropriated for carrying out section 403A of the Public
17 Health Service Act (42 U.S.C. 283a), the Secretary of
18 Health and Human Services, acting through the heads of
19 the appropriate agencies of the Public Health Service,
20 shall carry out a national program for the education of
21 health professionals and the public with respect to the
22 drug diethylstilbestrol (commonly known as DES). To the
23 extent appropriate, such national program shall use meth-
24 odologies developed through the education demonstration
25 program carried out under such section 403A. In develop-
26 ing and carrying out the national program, the Secretary

1 shall consult closely with representatives of nonprofit pri-
2 vate entities that represent individuals who have been ex-
3 posed to DES and that have expertise in community-based
4 information campaigns for the public and for health care
5 providers. The implementation of the national program
6 shall begin during fiscal year 1999.

7 **SEC. 102. RESEARCH ON OSTEOPOROSIS, PAGET'S DISEASE,**
8 **AND RELATED BONE DISORDERS.**

9 Section 409A(d) of the Public Health Service Act (42
10 U.S.C. 284e(d)) is amended by striking “and 1996” and
11 inserting “through 2001”.

12 **SEC. 103. RESEARCH ON CANCER.**

13 (a) **IN GENERAL.**—Section 417B(a) of the Public
14 Health Service Act (42 U.S.C. 286a–8(a)) is amended by
15 striking “and 1996” and inserting “through 2001”.

16 (b) **RESEARCH ON BREAST CANCER.**—Section
17 417B(b)(1) of the Public Health Service Act (42 U.S.C.
18 286a–8(b)(1)) is amended—

19 (1) in subparagraph (A), by striking “and
20 1996” and inserting “through 2001”; and

21 (2) in subparagraph (B), by striking “and
22 1996” and inserting “through 2001”.

23 (c) **RESEARCH ON OVARIAN AND RELATED CANCER**
24 **RESEARCH.**—Section 417B(b)(2) of the Public Health

1 Service Act (42 U.S.C. 286a–8(b)(2)) is amended by strik-
2 ing “and 1996” and inserting “through 2001”.

3 **SEC. 104. RESEARCH ON HEART ATTACK, STROKE, AND**
4 **OTHER CARDIOVASCULAR DISEASES IN**
5 **WOMEN.**

6 Subpart 2 of part C of title IV of the Public Health
7 Service Act (42 U.S.C. 285b et seq.) is amended by insert-
8 ing after section 424 the following:

9 “HEART ATTACK, STROKE, AND OTHER CARDIOVASCULAR
10 DISEASES IN WOMEN

11 “SEC. 424A. (a) IN GENERAL.—The Director of the
12 Institute shall expand, intensify, and coordinate research
13 and related activities of the Institute with respect to heart
14 attack, stroke, and other cardiovascular diseases in
15 women.

16 “(b) COORDINATION WITH OTHER INSTITUTES.—
17 The Director of the Institute shall coordinate activities
18 under subsection (a) with similar activities conducted by
19 the other national research institutes and agencies of the
20 National Institutes of Health to the extent that such Insti-
21 tutes and agencies have responsibilities that are related
22 to heart attack, stroke, and other cardiovascular diseases
23 in women.

24 “(c) CERTAIN PROGRAMS.—In carrying out sub-
25 section (a), the Director of the Institute shall conduct or
26 support research to expand the understanding of the

1 causes of, and to develop methods for preventing, cardio-
2 vascular diseases in women. Activities under such sub-
3 section shall include conducting and supporting the follow-
4 ing:

5 “(1) Research to determine the reasons under-
6 lying the prevalence of heart attack, stroke, and
7 other cardiovascular diseases in women, including
8 African-American women and other women who are
9 members of racial or ethnic minority groups.

10 “(2) Basic research concerning the etiology and
11 causes of cardiovascular diseases in women.

12 “(3) Epidemiological studies to address the fre-
13 quency and natural history of such diseases and the
14 differences among men and women, and among ra-
15 cial and ethnic groups, with respect to such diseases.

16 “(4) The development of safe, efficient, and
17 cost-effective diagnostic approaches to evaluating
18 women with suspected ischemic heart disease.

19 “(5) Clinical research for the development and
20 evaluation of new treatments for women, including
21 rehabilitation.

22 “(6) Studies to gain a better understanding of
23 methods of preventing cardiovascular diseases in
24 women, including applications of effective methods
25 for the control of blood pressure, lipids, and obesity.

1 “(7) Information and education programs for
2 patients and health care providers on risk factors as-
3 sociated with heart attack, stroke, and other cardio-
4 vascular diseases in women, and on the importance
5 of the prevention or control of such risk factors and
6 timely referral with appropriate diagnosis and treat-
7 ment. Such programs shall include information and
8 education on health-related behaviors that can im-
9 prove such important risk factors as smoking, obe-
10 sity, high blood cholesterol, and lack of exercise.

11 “(d) AUTHORIZATION OF APPROPRIATIONS.—For the
12 purpose of carrying out this section, there is authorized
13 to be appropriated such sums as may be necessary for
14 each of the fiscal years 1999 through 2001. The author-
15 ization of appropriations established in the preceding sen-
16 tence is in addition to any other authorization of appro-
17 priation that is available for such purpose.”.

18 **SEC. 105. AGING PROCESSES REGARDING WOMEN.**

19 Section 445I of the Public Health Service Act (42
20 U.S.C. 285e–11) is amended by striking “and 1996” and
21 inserting “through 2001”.

22 **SEC. 106. OFFICE OF RESEARCH ON WOMEN’S HEALTH.**

23 Section 486(d)(2) of the Public Health Service Act
24 (42 U.S.C. 287d(d)(2)) is amended by striking “Director

1 of the Office” and inserting “Director of the National In-
2 stitutes of Health”.

3 **TITLE II—PROVISIONS RELAT-**
4 **ING TO WOMEN’S HEALTH AT**
5 **THE CENTERS FOR DISEASE**
6 **CONTROL AND PREVENTION**

7 **SEC. 201. NATIONAL CENTER FOR HEALTH STATISTICS.**

8 Section 306(n) of the Public Health Service Act (42
9 U.S.C. 242k(n)) is amended—

10 (1) in paragraph (1), by striking “through
11 1998” and inserting “through 2002”; and

12 (2) in paragraph (2), by striking “through
13 1998” and inserting “through 2002”.

14 **SEC. 202. NATIONAL PROGRAM OF CANCER REGISTRIES.**

15 Section 399L(a) of the Public Health Service Act (42
16 U.S.C. 280e–4(a)) is amended by striking “through 1998”
17 and inserting “through 2002”.

18 **SEC. 203. NATIONAL BREAST AND CERVICAL CANCER**

19 **EARLY DETECTION PROGRAM.**

20 (a) GRANTS.—Section 1501(b) of the Public Health
21 Service Act (42 U.S.C. 300k(b)) is amended—

22 (1) in paragraph (1), by striking “nonprofit”;
23 and

24 (2) in paragraph (2), by striking “that are not
25 nonprofit entities”.

1 (b) PREVENTIVE HEALTH.—Section 1509(d) of the
2 Public Health Service Act (42 U.S.C. 300n–4a(d)(1)) is
3 amended by striking “through 1998” and inserting
4 “through 2002”.

5 (c) GENERAL PROGRAM.—Section 1510(a) of the
6 Public Health Service Act (42 U.S.C. 300n–5(a)) is
7 amended by striking “through 1998” and inserting
8 “through 2002”.

9 **SEC. 204. CENTERS FOR RESEARCH AND DEMONSTRATION**
10 **OF HEALTH PROMOTION.**

11 Section 1706(e) of the Public Health Service Act (42
12 U.S.C. 300u–5(e)) is amended by striking “through
13 1998” and inserting “through 2002”.

14 **SEC. 205. COMMUNITY PROGRAMS ON DOMESTIC VIO-**
15 **LENCE.**

16 Section 318(h)(2) of the Family Violence Prevention
17 and Services Act (42 U.S.C. 10418(h)(2)) is amended by
18 striking “fiscal year 1997” and inserting “for each of the
19 fiscal years 1997 through 2002”.
