**A BILL**

To abolish the National Endowment for the Arts and the  
National Council on the Arts.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “National Endowment  
5 for the Arts Termination Act of 1997”.

1 **SEC. 2. TERMINATION OF THE NATIONAL ENDOWMENT FOR**  
 2 **THE ARTS AND THE NATIONAL COUNCIL ON**  
 3 **THE ARTS.**

4 Sections 5, 5A, and 6 of the National Foundation on  
 5 the Arts and the Humanities Act of 1965 (20 U.S.C. 954,  
 6 954A, and 955) are repealed.

7 **SEC. 3. CONFORMING AMENDMENTS.**

8 (a) DECLARATION OF PURPOSE.—Section 2 of the  
 9 National Foundation on the Arts and the Humanities Act  
 10 of 1965 (20 U.S.C. 951) is amended—

11 (1) in paragraphs (1) and (6) by striking “arts  
 12 and the”;

13 (2) in paragraphs (2) and (5) by striking “and  
 14 the arts”;

15 (3) in paragraph (4) by striking “the arts and”;

16 (4) in paragraph (5) by striking—

17 (A) by striking “and the arts”; and

18 (B) by striking “arts and”;

19 (5) in paragraph (7)—

20 (A) by striking “practice of art and the”;

21 (B) by striking “artist or”; and

22 (C) by striking “creative”;

23 (6) in paragraph (9) by striking “arts and”;

24 (7) by striking paragraph (11); and

25 (8) in paragraph (12)—

26 (A) by striking “the Arts and”; and

1 (B) by redesignating such paragraph as  
2 paragraph (11).

3 (b) DEFINITIONS.—Section 3 of the National Foun-  
4 dation on the Arts and the Humanities Act of 1965 (20  
5 U.S.C. 952) is amended—

6 (1) by striking subsections (b), (c), and (f); and

7 (2) in subsection (d) by striking “, including  
8 programs” and all that follows through “under-  
9 standing of the arts,”;

10 (A) in paragraph (1)—

11 (i) by striking “the National Council  
12 on the Arts or”; and

13 (ii) by striking “, as the case may  
14 be,”;

15 (B) in paragraph (2)—

16 (i) by striking “sections 5(l) and” and  
17 inserting “section”;

18 (ii) in subparagraph (A) by striking  
19 “artistic or”; and

20 (iii) in subparagraph (B)—

21 (I) by striking “the National  
22 Council on the Arts and”; and

23 (II) by striking “, as the case  
24 may be,”; and

1 (C) by striking “(d) The” and inserting  
2 “(b) The”; and

3 (3) by redesignating subsections (e) and (g) as  
4 subsections (c) and (d), respectively.

5 (c) ESTABLISHMENT OF NATIONAL FOUNDATION ON  
6 THE ARTS AND HUMANITIES.—Section 4(a) of the Na-  
7 tional Foundation on the Arts and the Humanities Act  
8 of 1965 (20 U.S.C. 953(a)) is amended—

9 (1) in subsection (a)—

10 (A) by striking “the Arts and” each place  
11 it appears; and

12 (B) by striking “a National Endowment  
13 for the Arts,”;

14 (2) in subsection (b) by striking “and the arts”;  
15 and

16 (3) in the heading of such section by striking  
17 “THE ARTS AND”.

18 (d) FEDERAL COUNCIL ON THE ARTS AND THE HU-  
19 MANITIES.—Section 9 of the National Foundation on the  
20 Arts and the Humanities Act of 1965 (20 U.S.C. 958)  
21 is amended—

22 (1) in subsection (a) by striking “the Arts  
23 and”;

24 (2) in subsection (b) by striking “the Chair-  
25 person of the National Endowment for the Arts,”;

1 (3) in subsection (c)—

14 (e) ADMINISTRATIVE FUNCTIONS.—Section 10 of the  
15 National Foundation on the Arts and the Humanities Act  
16 of 1965 (20 U.S.C. 959) is amended—

17 (1) in subsection (a)—

18 (A) in the matter preceding paragraph

20 (i) by striking “in them”;

21 (ii) by striking “the Chairperson of  
22 the National Endowment for the Arts

7 ities”;

10 (iii) by striking “sections 5(c) and”  
11 and inserting “section”; and

12 (D) in paragraph (3) by striking “define  
13 their duties, and supervise and direct their ac-  
14 tivities” and inserting “define the activities of  
15 the employees, and supervise and direct the ac-  
16 tivities of the employees”;

17 (2) in subsection (b)—

18 (A) by striking paragraphs (1), (2), and  
19 (3); and

20 (B) in paragraph (4)—

21 (i) by striking “one of its Endow-  
22 ments and received by the Chairperson of  
23 an Endowment” and inserting “the Na-  
24 tional Endowment for the Humanities and

1 received by the Chairperson of that En-  
2 dowment”; and

3 (ii) by striking “(4)”;

4 (3) by striking subsection (c);

5 (4) in subsection (d)—

13 Section 11 of the National Foundation on the Arts  
 14 and the Humanities Act of 1965 (20 U.S.C. 960) is

4 **SEC. 5. SHORT TITLE.**

5 Section 1 of the National Foundation on the Arts and  
6 the Humanities Act of 1965 (20 U.S.C. 951 note) is  
7 amended by striking “the Arts and”.

8 **SEC. 6. TRANSITION PROVISIONS.**

9 The Director of the Office of Management and Budg-  
10 et shall provide for the termination of the affairs of the  
11 National Endowment for the Arts and the National Coun-  
12 cil on the Arts, including the appropriate transfer or other  
13 disposition of personnel, assets, liabilities, grants, con-  
14 tracts, property, records, and unexpended balances of ap-  
15 propriations, authorizations, allocations, and other funds  
16 held, used, arising from, available to, or to be made avail-  
17 able in connection with implementing the authorities ter-  
18 minated by the amendments made by this Act.

19 **SEC. 7. EFFECTIVE DATES.**

20 (a) **GENERAL EFFECTIVE DATE.**—Except as pro-  
21 vided in subsection (b), this Act shall take effect on the  
22 date of enactment of this Act.

23 (b) **EFFECTIVE DATE OF AMENDMENTS.**—Sections  
24 2, 3, 4, and 5 shall take effect on the first day of the

- 1 first fiscal year beginning after the date of enactment of
- 2 this Act.
