

In the Senate of the United States,

August 5, 1999.

Resolved, That the resolution from the House of Representatives (H. Con. Res. 167) entitled “Concurrent resolution authorizing the Architect of the Capitol to permit temporary construction and other work on the Capitol Grounds that may be necessary for construction of a building on Constitution Avenue Northwest, between 2nd Street Northwest and Louisiana Avenue Northwest.”, do pass with the following

AMENDMENTS:

1 **(1)**Page 1, strike out all after line 3 over to and including

2 line 7 on page 2 and insert:

3 *The Architect of the Capitol may permit temporary*
4 *construction and other work on the Capitol Grounds as fol-*
5 *lows:*

6 *(1) As may be necessary for the demolition of the*
7 *existing building of the Carpenters and Joiners of*
8 *America and the construction of a new building of the*
9 *Carpenters and Joiners of America on Constitution*

1 *Avenue Northwest between 2nd Street Northwest and*
2 *Louisiana Avenue Northwest in a manner consistent*
3 *with the terms of this resolution. Such work may in-*
4 *clude activities resulting in temporary obstruction of*
5 *the curbside parking lane on Louisiana Avenue*
6 *Northwest between Constitution Avenue Northwest*
7 *and 1st Street Northwest, adjacent to the side of the*
8 *existing building of the Carpenters and Joiners of*
9 *America on Louisiana Avenue Northwest. Such*
10 *obstruction—*

11 *(A) shall be consistent with the terms of*
12 *paragraphs (2) and (3);*

13 *(B) shall not extend in width more than 8*
14 *feet from the curb adjacent to the existing build-*
15 *ing of the Carpenters and Joiners of America;*
16 *and*

17 *(C) shall extend in length along the curb of*
18 *Louisiana Avenue Northwest adjacent to the ex-*
19 *isting building of the Carpenters and Joiners of*
20 *America, from a point 56 feet from the intersec-*
21 *tion of the curbs of Constitution Avenue North-*
22 *west and Louisiana Avenue Northwest adjacent*
23 *to the existing building of the Carpenters and*
24 *Joiners of America to a point 40 feet from the*
25 *intersection of the curbs of the Louisiana Avenue*

1 *Northwest and 1st Street Northwest adjacent to*
2 *the existing building of the Carpenters and Join-*
3 *ers of America.*

4 (2) *Such construction shall include a covered*
5 *walkway for pedestrian access, including access for*
6 *disabled individuals, on Constitution Avenue North-*
7 *west between 2nd Street Northwest and Louisiana Av-*
8 *enue Northwest, to be constructed within the existing*
9 *sidewalk area on Constitution Avenue Northwest ad-*
10 *acent to the existing building of the Carpenters and*
11 *Joiners of America, to be constructed in accordance*
12 *with specifications approved by the Architect of the*
13 *Capitol.*

14 (3) *Such construction shall ensure access to any*
15 *existing fire hydrants by keeping clear a minimum*
16 *radius of 3 feet around any fire hydrants, or accord-*
17 *ing to health and safety requirements as approved by*
18 *the Architect of the Capitol.*

19 **(2)**Page 3, after line 4, insert:

20 (c) *No construction shall extend into the United States*
21 *Capitol Grounds except as otherwise provided in section 1.*
