**AN ACT**

To authorize the addition of certain parcels to the Effigy  
Mounds National Monument, Iowa.

1       *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Effigy Mounds Na-  
3 tional Monument Additions Act”.

4 **SEC. 2. DEFINITIONS.**

5 In this Act:

6 (1) **MAP.**—The term “map” means the map en-  
7 titled “Proposed Boundary Adjustments/Effigy  
8 Mounds National Monument”, numbered 394/800  
9 35, and dated May 1999.

10 (2) **MONUMENT.**—The term “Monument”  
11 means the Effigy Mounds National Monument,  
12 Iowa.

13 (3) **SECRETARY.**—The term “Secretary” means  
14 the Secretary of the Interior.

15 **SEC. 3. ADDITIONS TO EFFIGY MOUNDS NATIONAL MONU-  
16 MENT.**

17 (a) **IN GENERAL.**—The Secretary may acquire by  
18 purchase, from willing sellers only, each of the parcels de-  
19 scribed in subsection (b).

20 (b) **PARCELS.**—The parcels referred to in subsection  
21 (a) are the following:

22 (1) **FERGUSON/KISTLER TRACT.**—The parcel  
23 consisting of approximately 1054 acres of undevel-  
24 oped, privately-owned land located in portions of sec-  
25 tions 28, 29, 31, 32, and 33, T. 95 N., R. 3 W.,

1 Fairview Township, Allamakee County, Iowa, as de-  
2 picted on the map.

3 (2) RIVERFRONT TRACT.—The parcel consisting  
4 of approximately 50 acres of bottom land located be-  
5 tween the Mississippi River and the north unit of  
6 the Monument in sections 27 and 34, Fairview  
7 Township, Allamakee County, Iowa, as depicted on  
8 the map.

9 (c) BOUNDARY ADJUSTMENT.—On acquisition of a  
10 parcel described in subsection (b), the Secretary shall  
11 modify the boundary of the Monument to include the par-  
12 cel. Any parcel included within the boundary of the Monu-  
13 ment pursuant to this subsection shall be administered by  
14 the Secretary as part of the Monument.

15 (d) AVAILABILITY OF MAP.—The map shall be on file  
16 and available for public inspection in appropriate offices  
17 of the National Park Service.

18 (e) AUTHORIZATION OF APPROPRIATIONS.—There is  
19 authorized to be appropriated to carry out this Act  
20 \$750,000.
