## A BILL

To reauthorize grants for water resources research and technology institutes established under the Water Resources Research Act of 1984.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REAUTHORIZATION OF WATER RESOURCES RE-**  
4 **SEARCH ACT OF 1984.**

5 (a) WATER RESOURCES RESEARCH PROGRAM  
6 GRANTS.—Section 104(f)(1) of the Water Resources Re-  
7 search Act of 1984 (42 U.S.C. 10303(f)(1)) is amended  
8 by striking “\$5,000,000 for fiscal year 1996, \$7,000,000  
9 for each of fiscal years 1997 and 1998, and \$9,000,000  
10 for each of fiscal years 1999 and 2000” and inserting  
11 “\$9,000,000 for fiscal year 2001, \$10,000,000 for each  
12 of fiscal years 2002 and 2003, and \$12,000,000 for each  
13 of fiscal years 2004 and 2005”.

14 (b) GRANTS FOR RESEARCH FOCUSED ON WATER  
15 PROBLEMS OF INTERSTATE NATURE.—The first sentence  
16 of section 104(g)(1) of such Act (42 U.S.C. 10303(g)(1))  
17 is amended by striking “\$3,000,000 for each of fiscal  
18 years 1996 through 2000” and inserting “\$3,000,000 for  
19 fiscal year 2001, \$4,000,000 for each of fiscal years 2002  
20 and 2003, and \$6,000,000 for each of fiscal years 2004  
21 and 2005”.
