To reauthorize the Atlantic Coastal Fisheries Cooperative
Management Act.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Atlantic Coastal Fish-
3 eries Act of 2000”.

4 **SEC. 2. REAUTHORIZATION OF ATLANTIC COASTAL FISH-**
5 **ERIES COOPERATIVE MANAGEMENT ACT.**

6 (a) **AUTHORIZATION OF APPROPRIATIONS.**—Section
7 811 of the Atlantic Coastal Fisheries Cooperative Manage-
8 ment Act (16 U.S.C. 5108) is amended to read as follows:

9 **“SEC. 811. AUTHORIZATION OF APPROPRIATIONS.**

10 “(a) **IN GENERAL.**—To carry out this title, there are
11 authorized to be appropriated \$10,000,000 for each of fis-
12 cal years 2001 through 2005.

13 “(b) **COOPERATIVE STATISTICS PROGRAM.**—
14 Amounts authorized under subsection (a) may be used by
15 the Secretary to support the Commission’s cooperative
16 statistics program.

17 “(c) **REPORTS.**—

18 “(1) **ANNUAL REPORT TO THE SECRETARY.**—
19 The Secretary shall require, as a condition of pro-
20 viding financial assistance under this title, that the
21 Commission and each State receiving such assistance
22 submit to the Secretary an annual report that pro-
23 vides a detailed accounting of the use of the assist-
24 ance.

25 “(2) **BIENNIAL REPORTS TO THE CONGRESS.**—
26 The Secretary shall submit biennial reports to the

1 Committee on Resources of the House of Represent-
2 atives and the Committee on Commerce, Science,
3 and Transportation of the Senate on the use of Fed-
4 eral assistance provided to the Commission and the
5 States under this title. Each biennial report shall
6 evaluate the success of such assistance in imple-
7 menting this title.”.

8 (b) TECHNICAL CORRECTIONS.—

9 (1) IN GENERAL.—Such Act is amended—

10 (A) in section 802(3) (16 U.S.C. 5101(3))
11 by striking “such resources in” and inserting
12 “such resources is”; and

13 (B) by striking section 812 and the second
14 section 811.

15 (2) AMENDMENTS TO REPEAL NOT AF-
16 FECTED.—The amendments made by paragraph
17 (1)(B) shall not affect any amendment or repeal
18 made by the sections struck by that paragraph.

19 (3) SHORT TITLE REFERENCES.—Such Act is
20 further amended by striking “Magnuson Fishery”

1 each place it appears and inserting “Magnuson-Ste-
2 vens Fishery”.
