A BILL

To amend the Dayton Aviation Heritage Preservation Act of 1992 to clarify the areas included in the Dayton Aviation Heritage National Historical Park and to authorize appropriations for that park.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Dayton Aviation Herit-
3 age Preservation Amendments Act of 2000”.

4 **SEC. 2. REVISION OF DAYTON AVIATION HERITAGE PRES-**
5 **ERVATION ACT OF 1992.**

6 (a) AREAS INCLUDED IN PARK.—Section 101(b) of
7 the Dayton Aviation Heritage Preservation Act of 1992
8 (16 U.S.C. 410ww(b)) is amended to read as follows:

9 “(b) AREAS INCLUDED.—The park shall consist of
10 the following sites, as generally depicted on a map entitled
11 ‘Dayton Aviation Heritage National Historical Park’,
12 numbered ____ and dated ____:

13 “(1) A core parcel in Dayton, Ohio, which shall
14 consist of the Wright Cycle Company building, Hoo-
15 ver Block, and lands between.

16 “(2) The Setzer building property (also known
17 as the Aviation Trail building property), Dayton,
18 Ohio.

19 “(3) The residential properties at 26 South
20 Williams Street and at 30 South Williams Street,
21 Dayton, Ohio.

22 “(4) Huffman Prairie Flying Field, located at
23 Wright-Patterson Air Force Base, Ohio.

24 “(5) The Wright 1905 Flyer III and Wright
25 Hall, including constructed additions and attached

1 structures, known collectively as the John W. Berry,
2 Sr. Wright Brothers Aviation Center, Dayton, Ohio.

3 “(6) The Paul Laurence Dunbar State Memo-
4 rial, Dayton, Ohio.”.

5 (b) AUTHORIZATION OF APPROPRIATIONS.—Section
6 109 of such Act (16 U.S.C. 410ww-8) is amended by
7 striking the colon after “title” and all that follows through
8 the end of the sentence and inserting a period.

9 (c) TECHNICAL CORRECTION.—Section 107 of such
10 Act (16 U.S.C. 410ww-6) is amended by striking “Sec-
11 retary of Interior” and inserting “Secretary of the Inte-
12 rior”.
