Mrs. MYRICK, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the bill (H.R. 819) to authorize appropriations for the Federal Maritime Commission for fiscal years 2000 and 2001.

1       *Resolved*, That at any time after the adoption of this  
2 resolution the Speaker may, pursuant to clause 2(b) of  
3 rule XVIII, declare the House resolved into the Committee  
4 of the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 819) to authorize appropriations  
6 for the Federal Maritime Commission for fiscal years  
7 2000 and 2001. The first reading of the bill shall be dis-

1   pensed with. General debate shall be confined to the bill  
2   and shall not exceed one hour equally divided and con-  
3   trolled by the chairman and ranking minority member of  
4   the Committee on Transportation and Infrastructure.  
5   After general debate the bill shall be considered for  
6   amendment under the five-minute rule. The bill shall be  
7   considered as read. During consideration of the bill for  
8   amendment, the chairman of the Committee of the Whole  
9   may accord priority in recognition on the basis of whether  
10  the Member offering an amendment has caused it to be  
11  printed in the portion of the Congressional Record des-  
12  ignated for that purpose in clause 8 of rule XVIII. Amend-  
13  ments so printed shall be considered as read. The chair-  
14  man of the Committee of the Whole may: (1) postpone  
15  until a time during further consideration in the Committee  
16  of the Whole a request for a recorded vote on any amend-  
17  ment; and (2) reduce to five minutes the minimum time  
18  for electronic voting on any postponed question that fol-  
19  lows another electronic vote without intervening business,  
20  provided that the minimum time for electronic voting on  
21  the first in any series of questions shall be 15 minutes.  
22  At the conclusion of consideration of the bill for amend-  
23  ment the Committee shall rise and report the bill to the  
24  House with such amendments as may have been adopted.  
25  The previous question shall be considered as ordered on

- 1 the bill and amendments thereto to final passage without
- 2 intervening motion except one motion to recommit with
- 3 or without instructions.
