A BILL

To amend the Reclamation Wastewater and Groundwater Study and Facilities Act to authorize the Secretary of the Interior to participate in the design, planning, and construction of the Denver Water Reuse project.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. DENVER WATER REUSE PROJECT.**

2 (a) **IN GENERAL.**—The Reclamation Wastewater and
3 Groundwater Study and Facilities Act (~~43~~ U.S.C. 390h
4 et seq.) is amended—

5 (1) by redesignating sections 1631, 1632, 1633,
6 and 1634 (~~43~~ U.S.C. 390h-13, 390h-14, 390h-15,
7 390h-16) as sections 1632, 1633, 1634, and 1635,
8 respectively; and

9 (2) by inserting after section 1630 the fol-
10 lowing:

11 **“SEC. 1631. DENVER WATER REUSE PROJECT.**

12 **“(a) AUTHORIZATION.**—The Secretary, in coopera-
13 tion with the appropriate State and local authorities, may
14 participate in the design, planning, and construction of the
15 Denver Water Reuse project to reclaim and reuse water
16 in the service area of the Denver Water Department of
17 the city and county of Denver, Colorado.

18 **“(b) COST SHARE.**—The Federal share of the cost
19 of the project described in subsection (a) shall not exceed
20 25 percent of the total cost.

21 **“(c) LIMITATION.**—Funds provided by the Secretary
22 shall not be used for the operation or maintenance of the
23 project described in subsection (a).”.

24 **(b) CONFORMING AMENDMENTS.**—

1 (1) The Reclamation Wastewater and Ground-
2 water Study and Facilities Act (as amended by sub-
3 section (a)(1)) is amended—

4 (A) in section 1632(a), by striking “1630”
5 and inserting “1631”;

6 (B) in section 1633(e), by striking “section
7 1633” and inserting “section 1634”; and

8 (C) in section 1634, by striking “section
9 1632” and inserting “section 1633”.

10 (2) The table of contents in section 2 of the
11 Reclamation Projects Authorization and Adjustment
12 Act of 1992 is amended by striking the items relat-
13 ing to sections 1631 through 1634 and inserting the
14 following:

“Sec. 1631. Denver water reuse project.

“Sec. 1632. Authorization of appropriations.

“Sec. 1633. Groundwater study.

“Sec. 1634. Authorization of appropriations.

“Sec. 1635. Willow Lake natural treatment system project.”.

15 **SECTION 1. DENVER WATER REUSE PROJECT.**

16 (a) *AUTHORIZATION.*—*The Secretary of the Interior,*
17 *in cooperation with the appropriate State and local au-*
18 *thorities, may participate in the design, planning, and con-*
19 *struction of the Denver Water Reuse Project (“Project”) to*
20 *reclaim and reuse water in the service area of the Denver*
21 *Water Department of the city and county of Denver, Colo-*
22 *rado.*

1 **(b) COST SHARE.**—*The Federal share of the cost of the*
 2 *Project shall not exceed 25 percent of the total cost.*

3 **(c) LIMITATION.**—*Funds provided by the Secretary*
 4 *shall not be used for the operation and maintenance of the*
 5 *Project.*

6 **(d) FUNDING.**—*Funds appropriated pursuant to sec-*
 7 *tion 1615 of the Reclamation Wastewater and Groundwater*
 8 *Study and Facilities Act may be used for the Project.*

9 **SEC. 2. RECLAMATION WASTEWATER AND GROUNDWATER**
 10 **STUDY AND FACILITIES ACT.**

11 *Design, planning, and construction of the Project au-*
 12 *thorized by the Act shall be in accordance with, and subject*
 13 *to the limitations contained in, the Reclamation Waste-*
 14 *water and Groundwater Study and Facilities Act (106*
 15 *Stat. 4663–4669, 43 U.S.C. 390h et seq.), as amended.*

Amend the title so as to read: A bill to authorize the Secretary of the Interior, pursuant to the provisions of the Reclamation Wastewater and Groundwater Study and Facilities Act to participate in the design, planning, and construction of the Denver Water Reuse project.
