Mr. HELMS from the Committee on Foreign Relations, reported the following original resolution; which was placed on the executive calendar

EXECUTIVE RESOLUTION

Directing the return of certain treaties to the President.

1 *Resolved*, That the Secretary of the Senate shall re-
2 turn to the President of the United States the following
3 treaties:

4 (1) The Optional Protocol of Signature Con-
5 cerning the Compulsory Settlement of Disputes. (Ex.
6 N, 861 (Treaty Doc. 86–14)).

7 (2) The International Convention on Civil Li-
8 ability for Oil Pollution Damage done in Brussels at
9 the International Legal Conference on Marine Pollu-

1 tion Damage, signed on November 29, 1969 (Ex. G,
2 91-2 (Treaty Doc. 91-17)).

3 (3)(A) The International Convention on the Es-
4 tablishment of an International Fund for Compensa-
5 tion for Oil Pollution Damage (Supplementary to the
6 International Convention on Civil Liability for Oil
7 Pollution Damage of 1969), done at Brussels, De-
8 cember 18, 1971.

9 (B) Certain Amendments to the International
10 Convention for the Prevention of Pollution of the
11 Sea by Oil of 1954, relating to Tanker Tank Size
12 and Arrangement and the Protection of the Great
13 Barrier Reef. (Ex. K, 92-2 (Treaty Doc. 92-23)).

14 (4) The Trademark Registration Treaty, done
15 at Vienna on June 12, 1973 (Ex. H, 94-1 (Treaty
16 Doc. 94-8)).

17 (5) The Treaty Between the United States of
18 America and the Union of Soviet Socialist Republics
19 on the Limitation of Strategic Offensive Arms and
20 the Protocol Thereto, together referred to as the
21 “SALT II Treaty”, both signed at Vienna, Austria,
22 on June 18, 1979, and related documents (Ex. Y,
23 96-1 (Treaty Doc. 96-25)).

24 (6) The Convention with Denmark for the
25 Avoidance of Double Taxation and the Prevention of

1 Fiscal Evasion with Respect to Taxes on Income,
2 signed at Washington on June 17, 1980 (Ex. Q, 96–
3 2 (Treaty Doc. 96–52)).

4 (7) The Convention on the Recognition of Stud-
5 ies, Diplomas and Degrees Concerning Higher Edu-
6 cation in the States Belonging to the Europe Re-
7 gion, signed on behalf of the United States on De-
8 cember 21, 1979 (Ex. V, 96–2 (Treaty Doc. 96–
9 57)).

10 (8) The Protocol Amending the Convention of
11 August 16, 1916, for the Protection of Migratory
12 Birds in Canada and the United States of America,
13 signed at Ottawa January 30, 1979 (Ex. W, 96–2
14 (Treaty Doc. 96–58)).

15 (9) The Supplementary Convention on Extra-
16 dition Between the United States of America and
17 the Kingdom of Sweden, signed at Washington on
18 May 27, 1981 (Treaty Doc. 97–15).

21 ters, Amending the Convention Between the Govern-
22 ment of the United States of America and the Gov-
