## CONCURRENT RESOLUTION

Expressing the sense of Congress that the 2008 Olympic Games should not be held in Beijing unless the Government of the People's Republic of China releases all political prisoners, ratifies the International Covenant on Civil and Political Rights, and observes internationally recognized human rights.

Whereas the ~~International Olympic Committee is in the process of determining the venue of the Olympic Games in the year 2008 and is scheduled to make that decision at the IOC meeting scheduled for Moscow in July 2001;~~

Whereas the city of Beijing has made a proposal to the International Olympic Committee that the summer Olympic Games in the year 2008 be held in Beijing;

Whereas the Olympic Charter states that Olympism and the Olympic ideal seek to foster “respect for universal fundamental ethical principles”;

Whereas the United Nations General Assembly Resolution 48/11 (October 25, 1993) recognized “that the Olympic goal of the Olympic Movement is to build a peaceful and better world by educating the youth of the world through sport, practiced without discrimination of any kind and the Olympic spirit, which requires mutual understanding, promoted by friendship, solidarity and fair play”;

Whereas United National General Assembly Resolution 50/13 (November 7, 1995) stressed “the importance of the

principles of the Olympic charter, according to which any form of discrimination with regard to a country or a person on grounds of race, religion, politics, sex or otherwise is incompatible with the Olympic Movement”;

Whereas the Department of State’s Country Reports on Human Rights Practices for 2000 reports the following:

(1) “The [Chinese] government continued to commit widespread and well-documented human rights abuses, in violation of internationally accepted norms.”.

(2) “Abuses included instances of extra judicial killings, the use of torture, forced confessions, arbitrary arrest and detention, the mistreatment of prisoners, lengthy incommunicado detention, and denial of due process.”.

(3) “The Government infringed on citizens’ privacy rights.”.

(4) “The Government maintained tight restrictions on freedom of speech and of the press, and increased its efforts to control the Internet; self-censorship by journalists continued.”.

(5) “The Government severely restricted freedom of assembly and continued to restrict freedom of association.”.

(6) “The Government continued to restrict freedom of religion and intensified controls on some unregistered churches.”.

(7) “The Government continued to restrict freedom of movement.”.

(8) “The Government does not permit independent domestic nongovernmental organizations (NGOs) to monitor publicly human rights conditions.”.

(9) “[The Government has not stopped] violence against women (including coercive family planning prac-

tices—which sometimes include forced abortion and forced sterilization).”.

(10) “The Government continued to restrict tightly worker rights, and forced labor in prison facilities remains a serious problem. Child labor exists and appears to be a growing problem in rural areas as adult workers leave for better employment opportunities in urban areas.”.

(11) “Some minority groups, particularly Tibetan Buddhists and Muslim Uighurs, came under increasing pressure as the Government clamped down on dissent and ‘separatist’ activities.”;

1        Resolved by the House of Representatives (the Senate  
2 concurring), That the Congress—

3            (1) acknowledges and supports the January 16,  
4        2001, open letter released by Chinese dissidents and  
5        the families of imprisoned Chinese political prisoners  
6        stating that the release of China’s political prisoners  
7        would improve Beijing’s stature in its bid to host the  
8        2008 Olympic Games;

1           (2) expresses the view that, consistent with its  
2           stated principles, the International Olympic Com-  
3           mittee should not award the 2008 Olympics to Bei-  
4           jing unless the Government of the People's Republic  
5           of China releases all of China's political prisoners,  
6           ratifies the International Covenant on Civil and Po-  
7           litical Rights without major reservations, fully imple-  
8           ments the International Covenant on Economic, So-  
9           cial and Cultural Rights, and observes internation-  
10          ally recognized human rights;

11          (3) calls for the creation of an international  
12          Beijing Olympic Games Human Rights Campaign in  
13          the event that Beijing receives the Olympics to focus  
14          international pressure on the Government of the  
15          People's Republic of China to grant a general am-  
16          nesty for all political prisoners prior to the com-  
17          mencement of the 2008 Olympics as well as to ratify  
18          the International Covenant on Civil and Political  
19          Rights;

20          (4) calls on the Secretary of State to endorse  
21          publicly the creation of the Beijing Olympic Games  
22          Human Rights Campaign in the event that Beijing  
23          receives the Olympics, and to utilize all necessary  
24          diplomatic resources to encourage other nations to  
25          endorse and support the campaign as well, focusing

1 particular attention on member states of the Euro-  
2 pean Union and the Association of Southeast Asian  
3 Nations (ASEAN), Japan, Canada, Australia, the  
4 Nordic countries, and all other countries engaged in  
5 human rights dialogue with China;

6 (5) requests that the President, during his ex-  
7 pected participation in the Asia-Pacific Economic  
8 Cooperation (APEC) Leaders Summit in Shanghai  
9 in October 2001, call for the release of all Chinese  
10 political prisoners and Chinese ratification of the  
11 International Covenant on Civil and Political Rights;

12 (6) recommends that the Congressional-Execu-  
13 tive Commission on the People's Republic of China,  
14 established under title III of the U.S.-China Rela-  
15 tions Act of 2000 (Public Law 106-286), devote sig-  
16 nificant resources to monitoring any violations of the  
17 rights of political dissidents and political prisoners,  
18 or other increased abuses of internationally-recog-  
19 nized human rights, in the preparation to the 2008  
20 Olympic Games and during the Olympic Games  
21 themselves; and

22 (7) directs the Clerk of the House of Represent-  
23 atives to transmit a copy of this resolution to the  
24 senior International Olympic Committee representa-

1       tive in the United States with the request that it be  
2       circulated to all members of the Committee.

4           (1) *acknowledges and supports the January 16,*

15          *fies the International Covenant on Civil and Political*

20          (3) *calls for the creation of an international Bei-*  
21          *jing Olympic Games Human Rights Campaign in the*  
22          *event that Beijing receives the Olympics to focus*  
23          *international pressure on the Government of the Peo-*  
24          *ple's Republic of China to grant a general amnesty*  
25          *for all political prisoners prior to the commencement*

1 *of the 2008 Olympics as well as to ratify the Inter-*  
2 *national Covenant on Civil and Political Rights;*

3 *(4) calls on the Secretary of State to endorse*  
4 *publicly the creation of the Beijing Olympic Games*  
5 *Human Rights Campaign in the event that Beijing*  
6 *receives the Olympics, and to utilize all necessary*  
7 *diplomatic resources to encourage other nations to en-*  
8 *dorse and support the campaign as well, focusing*  
9 *particular attention on member states of the Euro-*  
10 *pean Union and the Association of Southeast Asian*  
11 *Nations (ASEAN), Japan, Canada, Australia, the*  
12 *Nordic countries, and all other countries engaged in*  
13 *human rights dialogue with China;*

14 *(5) requests that the President, during his ex-*  
15 *pected participation in the Asia-Pacific Economic*  
16 *Cooperation (APEC) Leaders Summit in Shanghai*  
17 *in October 2001, call for the release of all Chinese po-*  
18 *litical prisoners and Chinese ratification of the Inter-*  
19 *national Covenant on Civil and Political Rights;*

20 *(6) recommends that the Congressional-Executive*  
21 *Commission on the People's Republic of China, estab-*  
22 *lished under title III of the U.S.-China Relations Act*  
23 *of 2000 (Public Law 106–286), devote significant re-*  
24 *sources to monitoring any violations of the rights of*  
25 *political dissidents and political prisoners, or other*

1       *increased abuses of internationally-recognized human*  
2       *rights, in the preparation to the 2008 Olympic Games*  
3       *and during the Olympic Games themselves; and*

4               *(7) directs the Clerk of the House of Representa-*  
5       *tives to transmit a copy of this resolution to the sen-*  
6       *ior International Olympic Committee representative*  
7       *in the United States with the request that it be cir-*  
8       *culated to all members of the Committee.*
