## A BILL

To revise the boundary of the Tumacacori National Historical Park in the State of Arizona.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Tumacacori National*  
5 *Historical Park Boundary Revision Act of 2001”.*

1 **SEC. 2. FINDINGS AND PURPOSES.**

2 (a) *FINDINGS.*—*The Congress finds the following:*

3 (1) *Tumacacori Mission in southern Arizona*  
4 *was declared a National Monument in 1908 in rec-*  
5 *ognition of its great historical significance as “one of*  
6 *the oldest mission ruins in the southwest”.*

7 (2) *In establishing Tumacacori National Histor-*  
8 *ical Park in 1990 to include the Tumacacori Mission*  
9 *and the ruins of the mission of Los Santos Angeles de*  
10 *Guevavi and the Kino visita and rancheria of*  
11 *Calabazas, Congress recognized the importance of*  
12 *these sites “to protect and interpret, for the education*  
13 *and benefit of the public, sites in the State of Arizona*  
14 *associated with the early Spanish missionaries and*  
15 *explorers of the 17th and 18th centuries”.*

16 (3) *Tumacacori National Historical Park plays*  
17 *a major role in interpreting the Spanish colonial her-*  
18 *itage of the United States.*

19 (b) *PURPOSES.*—*The purposes of this Act are—*

20 (1) *to protect and interpret the resources associ-*  
21 *ated with the Tumacacori Mission by revising the*  
22 *boundary of Tumacacori National Historical Park to*  
23 *include approximately 310 acres of land adjacent to*  
24 *the park; and*

1           (2) to enhance the visitor experience at  
2           Tumacacori by developing access to these associated  
3           mission resources.

4   **SEC. 3. BOUNDARY REVISION, TUMACACORI NATIONAL HIS-**  
5                           **TORICAL PARK, ARIZONA.**

6           Section 1(b) of Public Law 101-344 (16 U.S.C.  
7   410ss(b)) is amended—

8           (1) by inserting after the first sentence the fol-  
9           lowing new sentence: “The park shall also consist of  
10          approximately 310 acres of land adjacent to the origi-  
11          nal Tumacacori unit of the park and generally de-  
12          picted on the map entitled ‘Tumacacori National  
13          Historical Park, Arizona Proposed Boundary Revi-  
14          sion 2001’, numbered 310/80,044, and dated July  
15          2001.”; and

16          (2) in the last sentence—

17                   (A) by striking “The map” and inserting  
18                   “*The maps*”; and

19                   (B) by striking “the offices” and inserting  
20                   “*the appropriate offices*”.
