## **AN ACT**

To rename Wolf Trap Farm Park as “Wolf Trap National  
Park for the Performing Arts”, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*

3        **SECTION 1. RENAMING OF WOLF TRAP FARM PARK.**

4        (a) AMENDMENT.—The Wolf Trap Farm Park Act  
5        (Public Law 89-671; 16 U.S.C. 284 et seq.) is amended—

6                (1) by striking “Wolf Trap Farm Park” each  
7        place it appears and inserting “Wolf Trap National  
8        Park for the Performing Arts”;

1           (2) in section 2, by inserting before the final  
2           period “, except that laws, rules, or regulations that  
3           are applicable solely to units of the National Park  
4           System that are designated as a ‘National Park’  
5           shall not apply to Wolf Trap National Park for the  
6           Performing Arts”; and

7           (3) by adding at the end the following new sec-  
8           tion:

9           **“SEC. 14. REFERENCES.**

10          “(a) **BY FEDERAL EMPLOYEES.**—The Secretary of  
11          the Interior, any other Federal employee, and any em-  
12          ployee of the Foundation, with respect to any reference  
13          to the park in any map, publication, sign, notice, or other  
14          official document or communication of the Federal Gov-  
15          ernment or Foundation shall refer to the park as ‘Wolf  
16          Trap National Park for the Performing Arts’.

17          “(b) **OTHER SIGNS AND NOTICES.**—Any directional  
18          or official sign or notice pertaining to the park shall refer  
19          to the park as ‘Wolf Trap National Park for the Per-  
20          forming Arts’.

21          “(c) **FEDERAL LAWS AND DOCUMENTS.**—Any ref-  
22          erence in any law (other than this Act), regulation, docu-  
23          ment, record, map, or other paper of the United States  
24          to ‘Wolf Trap Farm Park’ shall be considered to be a ref-

1 erence to ‘Wolf Trap National Park for the Performing  
2 Arts’.”.

3 (b) APPLICABILITY.—Section 14(c) of the Wolf Trap  
4 Farm Park Act (as added by subsection (a) of this section)  
5 shall not apply to this Act.

6 **SEC. 2. TECHNICAL CORRECTIONS.**

7 Section 4(c) of the Wolf Trap Farm Park Act (Public  
8 Law 89–671; 16 U.S.C. 284c(c)) is amended—

9 (1) by realigning the second sentence so as to  
10 appear flush with the left margin; and

11 (2) by striking “Funds” and inserting “funds”.
