9 SECTION 1. (a) Section 101(a) of the Supplemental  
10 Appropriations Act, 1977 (2 U.S.C. 61h-6(a)) is amended  
11 in the first sentence by striking “four individual consult-  
12 ants” and inserting “six individual consultants”, and is  
13 amended in the second sentence by striking “one consult-  
14 ant” and inserting “not more than two individual consult-  
15 ants”.

16 (b) This section shall apply with respect to fiscal year  
17 2002 and each fiscal year thereafter.

18 SEC. 2. STUDENT LOAN REPAYMENTS. (a) DEFINI-  
19 TIONS.—In this section:

20 (1) EMPLOYEE OF THE SENATE.—The term “em-  
21 ployee of the Senate” has the meaning given the term  
22 in section 101 of the Congressional Accountability Act  
23 of 1995 (2 U.S.C. 1301).

1           (2) *EMPLOYING OFFICE.*—The term “employing  
2           office” means the employing office, as defined in such  
3           section 101, of an employee of the Senate.

4           (3) *STUDENT LOAN.*—The term “student loan”  
5           has the meaning given the term in section 5379 of  
6           title 5, United States Code.

7           (b) *STUDENT LOAN REPAYMENT PROGRAM.*—The head  
8           of an employing office may, in order to recruit or retain  
9           highly qualified personnel, establish a program under which  
10          the office may agree to repay (by direct payments on behalf  
11          of an employee of the Senate) any student loan previously  
12          taken out by such employee.

13          (c) *ADMINISTRATION.*—

14               (1) *IN GENERAL.*—The head of an employing of-  
15               fice shall carry out the program in accordance with  
16               the provisions of subsections (b) through (d) and sub-  
17               section (f) of section 5379 of title 5, United States  
18               Code.

19               (2) *APPLICATION.*—For purposes of this section,  
20               references in such provisions—

21                       (A) to an agency shall be considered to be  
22                       references to an employing office; and

23                       (B) to an employee shall be considered to be  
24                       references to an employee of the Senate.

1           (d) *AUTHORIZATION OF APPROPRIATIONS.*—*There are*  
2 *authorized to be appropriated to carry out this section such*  
3 *sums as may be necessary.*

4           (e) *EFFECTIVE DATE.*—*This section shall apply to fis-*  
5 *cal year 2002 and each fiscal year thereafter.*

6           *SEC. 3. (a) Agency contributions for employees whose*  
7 *salaries are disbursed by the Secretary of the Senate from*  
8 *the appropriations account “Expenses of the United States*  
9 *Senate Caucus on International Narcotics Control” under*  
10 *the heading “Congressional Operations” shall be paid from*  
11 *the Senate appropriations account for “Salaries, Officers*  
12 *and Employees”.*

13           (b) *This section shall apply to pay periods beginning*  
14 *on or after October 1, 2001.*

15           *SEC. 4. (a) Section 5(a) under the subheading “ADMIN-*  
16 *ISTRATIVE PROVISIONS” under the heading “SENATE”*  
17 *under title I of the Legislative Branch Appropriations Act,*  
18 *1996 (2 U.S.C. 58a note) is amended by striking “invoice*  
19 *ends” and inserting “invoice begins”.*

20           (b) *The amendment made by subsection (a) shall take*  
21 *effect on October 1, 2001, and shall apply to base service*  
22 *periods beginning on or after that date.*

23           *SEC. 5. (a) Section 120 of Public Law 97–51 (2 U.S.C.*  
24 *61g–6) is amended in the first sentence by striking*  
25 *“\$75,000” and inserting “\$100,000”.*

19 *For the Capitol Police Board for salaries of officers,*  
20 *members, and employees of the Capitol Police, including*  
21 *overtime, hazardous duty pay differential, clothing allow-*  
22 *ance of not more than \$600 each for members required to*  
23 *wear civilian attire, and Government contributions for*  
24 *health, retirement, Social Security, and other applicable*  
25 *employee benefits, \$112,922,000, of which \$55,296,000 is*

1 *provided to the Sergeant at Arms of the House of Represent-*  
2 *atives, to be disbursed by the Chief Administrative Officer*  
3 *of the House, and \$57,626,000 is provided to the Sergeant*  
4 *at Arms and Doorkeeper of the Senate, to be disbursed by*

6 *appropriated under this heading, such amounts as may be*  
7 *necessary may be transferred between the Sergeant at Arms*

9 *and Doorkeeper of the Senate, upon approval of the Com-*  
10 *mittee on Appropriations of the House of Representatives*  
11 *and the Committee on Appropriations of the Senate.*

13 *For the Capitol Police Board for necessary expenses*  
14 *of the Capitol Police, including motor vehicles, communica-*  
15 *tions and other equipment, security equipment and instal-*  
16 *lation, uniforms, weapons, supplies, materials, training,*  
17 *medical services, forensic services, stenographic services,*  
18 *personal and professional services, the employee assistance*  
19 *program, not more than \$2,000 for the awards program,*  
20 *postage, telephone service, travel advances, relocation of in-*  
21 *structor and liaison personnel for the Federal Law Enforce-*  
22 *ment Training Center, and \$85 per month for extra services*  
23 *performed for the Capitol Police Board by an employee of*  
24 *the Sergeant at Arms of the Senate or the House of Rep-*  
25 *resentatives designated by the Chairman of the Board,*

1 \$12,394,000, to be disbursed by the Capitol Police Board  
2 or their delegee: Provided, That, notwithstanding any other  
3 provision of law, the cost of basic training for the Capitol  
4 Police at the Federal Law Enforcement Training Center for  
5 fiscal year 2002 shall be paid by the Secretary of the Treas-  
6 ury from funds available to the Department of the Treas-  
7 ury.

8 *ADMINISTRATIVE PROVISION*

9 *SEC. 101. Amounts appropriated for fiscal year 2002*  
10 *for the Capitol Police Board for the Capitol Police may be*  
11 *transferred between the headings "SALARIES" and "GEN-*  
12 *ERAL EXPENSES" upon the approval of—*

13 *(1) the Committee on Appropriations of the*  
14 *House of Representatives, in the case of amounts*  
15 *transferred from the appropriation provided to the*  
16 *Sergeant at Arms of the House of Representatives*  
17 *under the heading "SALARIES";*

18 *(2) the Committee on Appropriations of the Sen-*  
19 *ate, in the case of amounts transferred from the ap-*  
20 *propriation provided to the Sergeant at Arms and*  
21 *Doorkeeper of the Senate under the heading "SALA-*  
22 *RIES"; and*

23 *(3) the Committees on Appropriations of the*  
24 *Senate and the House of Representatives, in the case*  
25 *of other transfers.*

1 *CAPITOL GUIDE SERVICE AND SPECIAL SERVICES OFFICE*

2 *For salaries and expenses of the Capitol Guide Service*  
3 *and Special Services Office, \$2,512,000, to be disbursed by*  
4 *the Secretary of the Senate: Provided, That no part of such*  
5 *amount may be used to employ more than 43 individuals:*  
6 *Provided further, That the Capitol Guide Board is author-*  
7 *ized, during emergencies, to employ not more than two ad-*  
8 *ditional individuals for not more than 120 days each, and*  
9 *not more than 10 additional individuals for not more than*  
10 *6 months each, for the Capitol Guide Service.*

11 *STATEMENTS OF APPROPRIATIONS*

12 *For the preparation, under the direction of the Com-*  
13 *mittees on Appropriations of the Senate and the House of*  
14 *Representatives, of the statements for the first session of the*  
15 *One Hundred Seventh Congress, showing appropriations*  
16 *made, indefinite appropriations, and contracts authorized,*  
17 *together with a chronological history of the regular appro-*  
18 *priations bills as required by law, \$30,000, to be paid to*  
19 *the persons designated by the chairmen of such committees*  
20 *to supervise the work.*

21 *OFFICE OF COMPLIANCE*22 *SALARIES AND EXPENSES*

23 *For salaries and expenses of the Office of Compliance,*  
24 *as authorized by section 305 of the Congressional Account-*  
25 *ability Act of 1995 (2 U.S.C. 1385), \$2,059,000.*

1                    *CONGRESSIONAL BUDGET OFFICE*2                                    *SALARIES AND EXPENSES*

3            *For salaries and expenses necessary to carry out the*  
4 *provisions of the Congressional Budget Act of 1974 (Public*  
5 *Law 93-344), including not more than \$3,000 to be ex-*  
6 *pended on the certification of the Director of the Congres-*  
7 *sional Budget Office in connection with official representa-*  
8 *tion and reception expenses, \$30,680,000: Provided, That*  
9 *no part of such amount may be used for the purchase or*  
10 *hire of a passenger motor vehicle.*

12            *SEC. 102. (a) The Director of the Congressional Budget*  
13 *Office may, by regulation, make applicable such provisions*  
14 *of chapter 41 of title 5, United States Code, as the Director*  
15 *determines necessary to provide hereafter for training of in-*  
16 *dividuals employed by the Congressional Budget Office.*

17            *(b) The implementing regulations shall provide for*  
18 *training that, in the determination of the Director, is con-*  
19 *sistent with the training provided by agencies subject to*  
20 *chapter 41 of title 5, United States Code.*

21            *(c) Any recovery of debt owed to the Congressional*  
22 *Budget Office under this section and its implementing regu-*  
23 *lations shall be credited to the appropriations account*  
24 *available for training employees of the Office at the time*  
25 *of recovery.*

1       (d) *This section shall apply to fiscal year 2002 and*  
2 *each fiscal year thereafter.*

3       SEC. 103. *Section 105(a) of the Legislative Branch Ap-*  
4 *propriations Act, 1996 (2 U.S.C. § 606(a)), is amended by*  
5 *striking “or discarding.” and inserting “sale, trade-in, or*  
6 *discarding.”, and by adding at the end the following:*  
7 *“Amounts received for the sale or trade-in of personal prop-*  
8 *erty shall be credited to funds available for the operations*  
9 *of the Congressional Budget Office and be available for the*  
10 *costs of acquiring the same or similar property. Such funds*  
11 *shall be available for such purposes during the fiscal year*  
12 *in which received and the following fiscal year.”.*

13       SEC. 104. (a) *The Director of the Congressional Budget*  
14 *Office may, in order to recruit or retain qualified personnel,*  
15 *establish and maintain hereafter a program under which*  
16 *the Office may agree to repay (by direct payments on behalf*  
17 *of the employee) all or a portion of any student loan pre-*  
18 *viously taken out by such employee.*

19       (b) *The Director may, by regulation, make applicable*  
20 *such provisions of section 5379 of title 5, United States*  
21 *Code as the Director determines necessary to provide for*  
22 *such program.*

23       (c) *The regulations shall provide the amount paid by*  
24 *the Office may not exceed—*

1           (1) \$6,000 for any employee in any calendar  
2           year; or

3           (2) a total of \$40,000 in the case of any em-  
4           ployee.

5           (d) The Office may not reimburse an employee for any  
6           repayments made by such employee prior to the Office en-  
7           tering into an agreement under this section with such em-  
8           ployee.

9           (e) Any amount repaid by, or recovered from, an indi-  
10          vidual under this section and its implementing regulations  
11          shall be credited to the appropriation account available for  
12          salaries and expenses of the Office at the time of repayment  
13          or recovery.

14          (f) This section shall apply to fiscal year 2002 and  
15          each fiscal year thereafter.

17                            *CAPITOL BUILDINGS AND GROUNDS*

18                            *CAPITOL BUILDINGS*

19                            *SALARIES AND EXPENSES*

20           *For salaries for the Architect of the Capitol, the Assist-*  
21           *ant Architect of the Capitol, and other personal services,*  
22           *at rates of pay provided by law; for surveys and studies*  
23           *in connection with activities under the care of the Architect*  
24           *of the Capitol; for all necessary expenses for the mainte-*  
25           *nance, care and operation of the Capitol and electrical sub-*

1 *stations of the Senate and House office buildings under the*  
2 *jurisdiction of the Architect of the Capitol, including fur-*  
3 *nishings and office equipment, including not more than*  
4 *\$1,000 for official reception and representation expenses, to*  
5 *be expended as the Architect of the Capitol may approve;*  
6 *for purchase or exchange, maintenance and operation of a*  
7 *passenger motor vehicle; and not to exceed \$20,000 for at-*  
8 *tendance, when specifically authorized by the Architect of*  
9 *the Capitol, at meetings or conventions in connection with*  
10 *subjects related to work under the Architect of the Capitol,*  
11 *\$54,000,000, of which \$5,000,000 shall remain available*  
12 *until expended: Provided, That the Architect of the Capitol,*  
13 *in consultation with the Comptroller General or his des-*  
14 *ignee, shall appoint a Chief Financial Officer within 90*  
15 *days after the date of enactment of this Act: Provided fur-*  
16 *ther, That notwithstanding any other provision of law and*  
17 *subject to the availability of appropriations, the Architect*  
18 *of the Capitol is authorized to secure, through multi-year*  
19 *rental, lease, or other appropriate agreement, the property*  
20 *located at 67 K Street, S.W., Washington, D.C., for use of*  
21 *Legislative Branch agencies, and to incur any necessary in-*  
22 *cidental expenses including maintenance, alterations, and*  
23 *repairs in connection therewith: Provided further, That in*  
24 *connection with the property referred to under the preceding*  
25 *proviso, the Architect of the Capitol is authorized to expend*

1 *funds appropriated to the Architect of the Capitol for the*  
 2 *purpose of the operations and support of Legislative Branch*  
 3 *agencies, including the United States Capitol Police, as*  
 4 *may be required for that purpose.*

5 *CAPITOL GROUNDS*

6 *For all necessary expenses for care and improvement*  
 7 *of grounds surrounding the Capitol, the Senate and House*  
 8 *office buildings, and the Capitol Power Plant, \$6,000,000.*

9 *SENATE OFFICE BUILDINGS*

10 *For all necessary expenses for the maintenance, care*  
 11 *and operation of Senate office buildings; and furniture and*  
 12 *furnishings to be expended under the control and super-*  
 13 *vision of the Architect of the Capitol, \$47,500,000, of which*  
 14 *\$3,400,000 shall remain available until expended.*

15 **(3)**Page 17, strike out all after line 23 over to and includ-

18 *For all necessary expenses for the maintenance, care*  
 19 *and operation of the Capitol Power Plant; lighting, heating,*

 22 *office buildings, Library of Congress buildings, and the*  
 23 *grounds about the same, Botanic Garden, Senate garage,*

 25 *in any of such buildings; heating the Government Printing*

1 *Office and Washington City Post Office, and heating and*  
2 *chilled water for air conditioning for the Supreme Court*  
3 *Building, the Union Station complex, the Thurgood Mar-*  
4 *shall Federal Judiciary Building and the Folger Shake-*  
5 *speare Library, expenses for which shall be advanced or re-*  
6 *imbursed upon request of the Architect of the Capitol and*  
7 *amounts so received shall be deposited into the Treasury*  
8 *to the credit of this appropriation, \$47,403,000, of which*  
9 *\$3,300,000 shall remain available until expended: Provided,*  
10 *That not more than \$4,400,000 of the funds credited or to*  
11 *be reimbursed to this appropriation as herein provided*  
12 *shall be available for obligation during fiscal year 2002.*

16 *For necessary expenses to carry out the provisions of*  
17 *section 203 of the Legislative Reorganization Act of 1946*  
18 *(2 U.S.C. 166) and to revise and extend the Annotated Con-*  
19 *stitution of the United States of America, \$81,139,000: Pro-*  
20 *vided, That no part of such amount may be used to pay*  
21 *any salary or expense in connection with any publication,*  
22 *or preparation of material therefor (except the Digest of*  
23 *Public General Bills), to be issued by the Library of Con-*  
24 *gress unless such publication has obtained prior approval*  
25 *of either the Committee on House Administration of the*

1 *House of Representatives or the Committee on Rules and*
