A BILL

To amend title XVIII of the Social Security Act to provide for coverage of qualified acupuncturist services under part B of the Medicare Program, and to amend title 5, United States Code, to provide for coverage of such services under the Federal Employees Health Benefits Program.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Federal Acupuncture
3 Coverage Act of 2001”.

4 **SEC. 2. COVERAGE OF ACUPUNCTURIST SERVICES UNDER**
5 **MEDICARE.**

6 (a) IN GENERAL.—Section 1861(s)(2) of the Social
7 Security Act (42 U.S.C. 1395x(s)(2)), as amended by sec-
8 tions 102(a) and 105(a) of the Medicare, Medicaid, and
9 SCHIP Benefits Improvement and Protection Act of
10 2000, as enacted into law by section 1(a)(6) of Public Law
11 106–554, is amended—

12 (1) by striking “and” at the end of subpara-
13 graph (U);

14 (2) by inserting “and” at the end of subpara-
15 graph (V); and

16 (3) by adding at the end the following new sub-
17 paragraph:

18 “(W) qualified acupuncturist services (as de-
19 fined in subsection (ww)); and”.

20 (b) SERVICES DESCRIBED.—Section 1861 of the So-
21 cial Security Act (42 U.S.C. 1395x), as amended by sec-
22 tions 102(b) and 105(b) of the Medicare, Medicaid, and
23 SCHIP Benefits Improvement and Protection Act of
24 2000, as enacted into law by section 1(a)(6) of Public Law
25 106–554, is amended by adding at the end the following
26 new subsection:

1 “Qualified Acupuncturist Services

2 “(ww)(1) The term ‘qualified acupuncturist services’
3 means such services furnished by a qualified acupuncturist
4 (as defined in paragraph (2)) and such services and sup-
5 plies furnished as an incident to services furnished by the
6 qualified acupuncturist which the qualified acupuncturist
7 is legally authorized to perform under State law (or the
8 State regulatory mechanism provided by State law).

9 “(2) The term ‘qualified acupuncturist’ means an in-
10 dividual who has been certified, licensed, or registered as
11 an acupuncturist by a State (or the State regulatory
12 mechanism provided by State law).”.

13 (c) PAYMENT RULES.—

14 (1) DETERMINATION OF AMOUNT OF PAY-
15 MENT.—Section 1833(a)(1) of the Social Security
16 Act (42 U.S.C. 1395l(a)(1)), as amended by sections
17 105(c) and 223(c) of the Medicare, Medicaid, and
18 SCHIP Benefits Improvement and Protection Act of
19 2000, as enacted into law by section 1(a)(6) of Pub-
20 lic Law 106–554, is amended—

21 (A) by striking “and” before “(U)”; and

22 (B) by inserting before the semicolon at
23 the end the following: “, and (V) with respect
24 to qualified acupuncturist services described in
25 section 1861(s)(2)(W), the amounts paid shall

1 be the amount determined by a fee schedule es-
2 tablished by the Secretary for purposes of this
3 clause (but in no event shall such amount ex-
4 ceed the fee schedule amount provided under
5 section 1848 for the same service performed by
6 a physician);”.

7 (2) SEPARATE PAYMENT FOR SERVICES OF IN-
8 STITUTIONAL PROVIDERS.—Section 1833(a)(2)(B)
9 of such Act (42 U.S.C. 1395l(a)(2)(B)) is amended,
10 in clauses (i) and (ii), by inserting “and in the case
11 of qualified acupuncturist services furnished at any
12 time” after “1999,” each place it appears.

13 (d) EFFECTIVE DATE.—The amendments made by
14 this section apply to services furnished on or after Janu-
15 ary 1, 2002.

16 **SEC. 3. COVERAGE OF ACUPUNCTURIST SERVICES UNDER**
17 **FEDERAL EMPLOYEES HEALTH BENEFIT**
18 **PLANS.**

19 (a) IN GENERAL.—Section 8902(k)(1) of title 5,
20 United States Code, is amended by inserting
21 “acupuncturist,” after “nurse midwife,” each place it ap-
22 pears.

1 (b) EFFECTIVE DATE.—The amendment made by
2 subsection (a) applies with respect to services provided
3 after December 31, 2001.
