A BILL

To establish age limitations for airmen.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. AGE AND OTHER LIMITATIONS.**

4 (a) GENERAL.—Notwithstanding any other provision
5 of law, beginning on the date that is ~~30 days~~ *6 months*
6 after the date of enactment of this Act—

1 (1) section 121.383(c) of title 14, Code of Fed-
 2 eral Regulations, shall not apply;

3 (2) no certificate holder may use the services of
 4 any person as a pilot on an airplane engaged in op-
 5 erations under part 121 of title 14, Code of Federal
 6 Regulations, if that person is ~~65~~ 63 years of age or
 7 older; and

8 (3) no person may serve as a pilot on an air-
 9 plane engaged in operations under part 121 of title
 10 14, Code of Federal Regulations, if that person is ~~65~~
 11 63 years of age or older.

12 (b) CERTIFICATE HOLDER.—For purposes of this
 13 section, the term “certificate holder” means a holder of
 14 a certificate to operate as an air carrier or commercial
 15 operator issued by the Federal Aviation Administration.

16 **SEC. 2. RESERVATION OF SAFETY AUTHORITY.**

17 *This Act does not change the authority of the Federal*
 18 *Aviation Administration to take steps to ensure the safety*
 19 *of air transportation operations involving a pilot who has*
 20 *reached the age of 60, including its authority—*

21 *(1) to require such a pilot to undergo additional*
 22 *or more stringent medical, cognitive, or proficiency*
 23 *testing in order to retain certification; or*

24 *(2) to establish crew pairing standards for crews*
 25 *with such a pilot.*
